#### **EXECUTIVE ORDER NO. 036-2021**

AN ORDER DECLARING TEMPORARY CLOSURE OF PORTION OF BONIFACIO AND DEL PILAR STREETS IN THE VICINITY OF THE MUNICIPAL PUBLIC MARKET TO ACCOMMODATE THE SELLING OF GOODS, MERCHANDISE, FOODSTUFFS, COMMODITIES AND OTHER SIMILAR ARTICLES OF COMMERCE ON DECEMBER 21-31, 2021

**WHEREAS**, pursuant to Republic Act No. 7160, any municipality may temporarily close and regulate the use of any local street, road, thoroughfare, or public place where shopping malls, Sunday markets, flea or night markets, or shopping areas may be established and where goods, merchandise, foodstuff, commodities, or articles of commerce may be sold and dispensed to the general public;

WHEREAS, the Local Chief Executive was authorized by the Sangguniang Bayan to temporarily close a portion of Bonifacio and Del Pilar Streets thru Sanggunian Bayan Ordinance No. 05-2017 dated December 11, 2017;

WHEREAS, it has been customary in the Municipality of Pinamalayan to utilize the portion of the aforementioned streets for the holiday season as temporary shopping areas to the public.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR, Local Chief Executive of the Municipality of Pinamalayan, by virtue of the powers vested in me by law do hereby order the temporary closure of portion of Bonifacio and Del Pilar Street in the vicinity of the Municipal Public Market to accommodate the selling of goods merchandise, foodstuffs, commodities and other similar articles of commerce on December 21-31, 2021.

**SECTION 1. SCOPE.** The left portion of Bonifacio Street going South, from Buenas Glassware to Food Terminal and Del Pilar Street from Juan Luna Street in front of Blanco Trading to corner Morente Street and from Blanco Trading to corner Bonifacio in the vicinity of Pinamalayan Public Market shall be closed to accommodate the selling of goods, merchandise, foodstuffs, commodities and other similar articles of commerce

**Section 2. DURATION**. The temporary closure for Bonifacio Street (from Buenas Glassware to Food Terminal) and Del Pilar Street (from Juan Luna Street to Morente Street) shall take effect on December 24 and 31, 2021 only while in Del Pilar Street (from Blanco Trading to corner Bonifacio) closure will be on December 21-23, 2021 & December 25-30, 2021.

**SECTION 3. TERMS AND CONDITIONS.** The following terms and conditions shall be implemented:

- That a substitute route with corresponding routing plan shall be provided;
- b. That the alternate route shall be properly maintained for public safety until such duration that the subject road will be opened back to the public;
- That the residents of the area covered by the closure of road shall be given access;
- d. That all relevant laws and department orders appertaining temporary closure of roads and its guidelines shall be strictly followed.

**SECTION 4. SUPERVISION.** The Market Operations Department (MOD) shall see to it that safety health protocols such as wearing of facemasks and social distancing are strictly observed. The MOD shall also take charge of the public announcement informing the public that the aforementioned road is subject for temporary closure and stating the specific day and time.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately.



Greetings!



This Office would like to ask for your approval on the proposed set-up of vendors during the Holiday Season. This proposal is almost like last year except that all vendors (resident or not) are allowed to sell, and they shall observe health standard protocol set by the Inter-agency Task Force (IATF).

The undersigned would like to propose the following:

- 1. The temporary closure of portion of Bonifacio Street and Del Pilar Street in the vicinity of Pinamalayan Public Market (as per *Resolution No. 4109-2018*) will start on December 21 to 31, 2021. December 21 is intended for assembling of tents and tables only. December 22 is the official opening date.
- 2. During the period of December 21 to 31, the fruit and vegetable vendors shall be in portion of Del Pilar and Bonifacio Street representing the sign on the floor plan. Previously, these vendors occupied 5 rows in Del Pilar Street in between the Vegetable Section and Shiem Restaurant. However, to observed proper distancing, only 4 rows are allowed on this area and in excess, this Office is recommending the use of Municipal Food Terminal and portion of Bonifacio Street allotting 2 columns only.
- 3. On the 24<sup>th</sup> and 31<sup>st</sup> of December, the peak and probably the most volume of shoppers, this Office is proposing the closure of Wet Section and Vegetable Section to control the entry and exit of the buying public. Only on this specific date, will there be personnel assigned to man the entry and exit point, the market personnel after their original function will be utilized but surely the assistance of at least 4 TMO personnel will be needed.
- 4. Also on the peak dates, that is the only time the portion of Del Pilar Street in front of the Wet Section will be closed. The rest of the days, it will be open. That area is intended for the bread, sweet delicacies, and rice cakes vendors representing the sign on the floor plan. On the other hand, "torotot" vendors will be accommodated also, they will be placed either in Bonifacio Street or Del Pilar Street depending on which is available.
- 5. Finally, may this office request the visibility of the PNP personnel to pacify the traffic flow at the Public Market premises during this season.




