EXECUTIVE ORDER NO. 05-2022

AN ORDER CREATING AND MOBILIZING THE MUNICIPAL PLANNING TEAM (MPT) FOR THE PREPARATION OF THE MEDIUM-TERM DEVELOPMENT PLAN (MTDP) 2023-2025, DESIGNATING ITS COMPOSITION, ROLES AND RESPONSIBILITIES, AND FOR OTHER PURPOSES.

- WHEREAS, the Local Government Code of 1991 or Republic Act (RA) 7160 provides that each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian;
- WHEREAS, the Municipal Government of Pinamalayan (MGOP) has an approved Comprehensive Land Use Plan (CLUP) 2015-2045 and Comprehensive Development Plan (CDP) 2019-2028 as of year 2019;
- WHEREAS, there is an urgent need to recalibrate our plans of actions recognizing present realities and emerging challenges considering the COVID-19 pandemic, full assumption of devolved functions, services and facilities, perpetual concerns about climate change and disasters, economic recovery, and the agenda for governance and development of the incoming elective officials;
- WHEREAS, keeping the policies and strategies relevant and responsive to these challenges, the MGOP is on the process of reviewing and updating the contents of particular timelines of the approved CLUP and CDP leading to the formulation of the Medium-Term Development Plan (MTDP) 2023-2025, a term-based development plan;
- WHEREAS, RA 7160 further provides that the local development council shall assist the sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction, thus, it is critical to ensure that the local development council and its functional and sectoral committees composed of functionaries as providers of technical support and assistance are constituted and activated;
- NOW THEREFORE, I, ARISTEO APASAN BALDOS, JR., Local Chief Executive of Municipality of Pinamalayan, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby create and mobilize the Municipal Planning Team (MPT), to wit:

Section 2. ROLES AND RESPONSIBILITIES

2.1 Planning Core Committee (PCC)

- The PCC shall be the over-all committee responsible for supervision of all technical and administrative activities in the preparation of MTDP, including stakeholder consultation, meetings, sectoral workshops and plenary session.
- Consolidate/integrate all sectoral study reports.
- Prepare other needed implementation instruments and documents.
- Facilitate the presentation of the draft MTDP to the Municipal Development Council (MDC) for deliberation and adoption.
- Document the proceedings of all committee activities.

2.2 Sectoral/Functional Committees

- Conduct planning activities as maybe necessary.
- Responsible for the identification and preparation of respective sector activity venue.
- Conduct sector workshops to facilitate sub-sector presentation, critiquing and assessment.
- Consolidate/Integrate enhanced sub-sectors studies, underscoring findings and recommendations.
- Prepare and submit final sector study report including sector structured list of programs/projects/activities with corresponding project briefs and/or activity designs.
- Document the proceedings of all sector activities.

Section 3. RELATIONSHIP WITH THE MUNICIPAL DEVELOPMENT COUNCIL

The MPT shall act as the main technical component of the MDC and shall work closely with the MDC in crafting the MTDP.

Section 4. SUPPORT REQUIREMENTS

The Chairperson of the MDC through the MPT shall enjoin the involvement of concerned functionaries and may call upon the assistance of relevant units and/or personnel, through the respective department/office/agency heads, in the implementation of various activities relative to the formulation of the MTDP.

Section 5. EFFECTIVITY

The MPT shall exercise their duties and functions effective immediately.
