EXECUTIVE ORDER NO. 03-2022

AN ORDER DIRECTING THE TEMPORARY CLOSURE OF LEUTERIO AND JAENA STREETS AND PORTIONS OF MABINI STREET AND MADRID BOULEVARD FOR THE HOLDING OF TRADE FAIR OR "BARAKLAN" IN CELEBRATION OF 105TH FOUNDING ANNIVERSARY AND TOWN FIESTA OF MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Section 21 of Republic Act No. 7160 otherwise known as Local Government Code of 1991 allows the Local Government Unit to temporarily close the roads during Fiesta Celebration;

WHEREAS, the Local Chief Executive was authorized by the Sangguniang Bayan to temporarily close Leuterio and Jaena Streets and portions of Mabini Street and Madrid Blvd thru Ordinance No. 01-2018;

WHEREAS, it is deemed necessary to temporarily close the roads for a period of twenty five (25) days starting April 3, 2022 to April 28, 2022 for the holding of funfair and annual trade fair "Baraklan" wherein goods, merchandise, foodstuffs and other commodities will be dispensed to the public in celebration of the 105th Founding Anniversary and Town Fiesta.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR., Local Chief Executive of Municipality of Pinamalayan, by virtue of the powers vested in my by law, do hereby order the temporary closure of Leuterio and Jaena Streets and portions of Mabini Street and Madrid Blvd. from April 3, 2022 to April 28, 2022.

EFFECTIVITY. This Executive Order shall take effect on April 3, 2022.

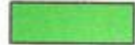


TEMPORARY CLOSURE OF LEUTERIO STREET, JAENA STREET, MABINI STREET AND MADRID BOULEVARD

ORDINANCE NO. 01 - 2018

ORDINANCE AMENDING SECTION 4. OF ORDINANCE NO. 01-2017 ENTITLED, "AN ORDINANCE DECLARING THE TEMPORARY CLOSURE TO VEHICULAR TRAFFIC THE PORTIONS OF STREETS IN THE POBLACION WITH THE SPECIFIC ACTIVITY AND DURATION PURSUANT TO ARTICLE 45, RULE VIII OF THE RULES AND REGULATIONS IMPLEMENTING THE LOCAL GOVERNMENT CODE OF 1991".

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro, that:

Section 1. TITLE - This Ordinance shall be known as Ordinance amending Section 4 of Ordinance No. 01-2017 entitled, "An Ordinance declaring the temporary closure to vehicular traffic the portions of streets in the poblacion with the specific activity and duration pursuant to Article 45, Rule VIII of the Rules and Regulations Implementing the Local Government Code of 1991".

Section 2. - This ordinance shall amend Section 4 of Ordinance No. 01-2017 with an addendum in the specified roads/streets covered by temporary closure for the holding of the annual trade fair of Baraklan during the period of fiesta celebration of the Municipality of Pinamalayan, Oriental Mindoro.

Section 3. - The Section 4 of Ordinance No. 01-2017 which states that "An authority to the Local Chief Executive is hereby given for temporary closure of **Westbound road shoulder portion of Madrid Boulevard (From Jaena to Leuterio Streets); full road portion of Jaena Street (Between Madrid Blvd. and Mabini St.); Eastbound road shoulder portion of Mabini St. (From Leuterio to Jaena Streets); and full road portion of Leuterio Street (Between Madrid Blvd. and Mabini St.)** of the Municipality of Pinamalayan, Oriental Mindoro for the duration of yearly town fiesta celebration or the Municipality's founding anniversary to be temporarily utilized as a space to accommodate the Baraklan and vendors which are traditionally established during the period of fiesta celebration" is hereby amended to read as follows:

"Section 4. **SCOPE** - An authority to the Local Chief Executive is hereby given for temporary closure of **Westbound road shoulder portion of Madrid Boulevard (From Jaena to Leuterio Streets); full road portion of Jaena Street (Between Madrid Blvd. and Mabini St.); Eastbound road shoulder portion of Mabini St. (From Leuterio to Jaena Streets); full road portion of Leuterio Street (Between Madrid Blvd. and Mabini St.) and full road portion of Burgos St (Between Mabini St. and Del Pilar St.)** of the Municipality of Pinamalayan, Oriental Mindoro for the duration of yearly town fiesta celebration or the Municipality's founding anniversary to be temporarily utilized as a space to accommodate the Baraklan and vendors which are traditionally established during the period of fiesta celebration"

Section 4. EFFECTIVITY - This Ordinance shall take effect upon its approval.


