**EXECUTIVE ORDER NO. 06-2022**

**AN ORDER CREATING THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO  
TECHNICAL WORKING GROUP ON POPULATION AND DEVELOPMENT PLANNING**

**WHEREAS**, the municipality of Pinamalayan has the mandate by virtue of the Local Government code to ensure the general welfare of its constituents and manage the development of its people and locality under its jurisdiction;

**WHEREAS**, local development planning is a mandated function of the LGU and a critical process and tool to ensure the general welfare of the population as mandated by the Local Government Code;

**WHEREAS**, in order to ensure that Local Development is centered on the needs of the people, there is a need to integrate population and development (Popdev) interrelationships and dynamics in each step of the development process;

**WHEREAS**, as a key strategy for Popdev Integration, Commission on Population and Development is providing technical assistance to LGU's in integration of population dynamics in local development planning and policy development.
