EXECUTIVE ORDER NO. 07-2022

AN EXECUTIVE ORDER CREATING THE LOCAL CLIMATE CHANGE ACTION PLAN (LCCAP) CORE TEAM AND TECHNICAL WORKING GROUP (TWG) IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Section 2a, 15, 3i of RA 7160 otherwise known as Local Government Code mandates the Local Government Unit (LGU) to exercise their inherent powers such as police power, as well as share with the national government the responsibility in the management and maintenance of ecological balance in their respective territorial jurisdiction;

WHEREAS, Section 11, (2) of RA 10121 otherwise known as Disaster Risk Reduction and Management Act of 2010 states that LGU shall ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;

WHEREAS, Section 14 of RA 9729 otherwise known as Climate Change Act of 2009 states that LGUs shall be the frontline agencies in the formulation, planning and implementation of climate change action plans in their respective areas, consistent with the provisions of the Local Government Code, the Framework, and the National Climate Change Action Plan;

WHEREAS, it further states that local chief executive shall appoint the person responsible for the formulation and implementation of the local action plan;

WHEREAS, DILG Memorandum Circular No. 2014-135 suggests that the Local Chief Executive, shall form the LCCAP Core Team who will lead, oversee an ensure that LCCAP will be formulated, eventually approved, implemented, regularly monitored and updated when necessary.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor of Pinamalayan, by virtue of the powers vested in me by law, do hereby order the creation of the Local Climate Change Action Plan (LCCAP) Core Team and Technical Working Group (TWG) in the Municipality of Pinamalayan, Oriental Mindoro, as follows;

Section 2. DUTIES AND FUNCTIONS.

A. The LCCAP Core Team shall perform the following duties and functions:

- 1. Oversee and ensure that LCCAP is formulated and implemented upon approval by the Office of the Sangguniang Bayan;
- 2. Convene for a meeting at least annually to provide updates on implementation of LCCAP and to reflect changes in terms of social, economic, and environmental conditions and other emerging issues; and
- 3. Perform other functions that may be deemed necessary.

- B. The LCCAP TWG shall perform the following duties and functions:
 - Formulate the LCCAP based on the Enhanced LGU Guidebook on the Formulation of Local Climate Change Action Plan published by Local Government Academy – Department of the Interior and Local Government;
 - Update annually the LCCAP based on Vulnerability and Adaptation Assessment (VAA);
 - Ensure implementation of action plans proposed by their respective offices during LCCAP formulation; and
 - 4. Perform other functions that may be deemed necessary.
- C. The Secretariat of LCCAP Core Team shall furnish the Climate Change Commission with copies of action plans and all subsequent amendments, modifications and revisions thereof, within one (1) month from adoption.

Section 3. EFFECTIVITY. This order shall take effect immediately.
