EXECUTIVE ORDER NO. 15-2022

AN EXECUTIVE ORDER CREATING THE SPORTS WORKING COMMITTEE OF THE MUNICIPAL GOVERNMENT OF PINAMALAYAN

SECTION 2. DUTIES AND RESPONSIBILITIES. To ensure the success of the Sports Olympics, the Sports Working Committee shall perform the following tasks and responsibilities:
