All quotations may be typewritten or handwritten and may be placed in sealed envelope marked "Venue Decoration for 8th Annual PRAISE Recognition Rites" (RFQ No. 1007 )" and must be delivered/submitted on \_\_\_\_\_\_\_ at the BAC Secretariat Office, 2F Main Building, Municipal Compound, Pinamalayan, Oriental Mindoro.

Quotations shall be valid for three (3) working days from the deadline of submission of the same.

The delivery period shall be within fifteen (15) calendar days from receipt of the Purchase Order (PO). The supplier should inform the purchaser at least a day before the date of delivery. The delivery will be made only during working days and hours.

The applicable rate for late deliveries is one tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the procuring entity shall rescind the contract, without prejudice to other courses of action and remedies open to it.

The prospective supplier shall submit the following:

- a) Duly accomplished Quotation Form (Annex A), and
- b) Brochures of the items offered, if any.

The Municipal Government of Pinamalayanreserves the right to accept or reject any quotation, and to annul the procurement process and reject all quotations at any time prior to Contract award, without thereby incurring any liability to the affected supplier or suppliers. Municipal Government of Pinamalayanalso reserves the right to waive any required formality in the proposals received, and select the proposal which it determines to be the most advantageous to the government.
