EXECUTIVE ORDER NO. 21 -2022

AN ORDER RECONSTITUTING THE MUNICIPAL COMMITTEE ON ANTI-TRAFFICKING, AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (MCAT-VAWC) OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Republic Act No. 9208 declares that the state shall be given highest priority to the enactment of measures and development of programs that will promote human, dignity, protect the people from violence and exploitation, eliminate trafficking in persons, and mitigate pressure to involuntary migration and servitude of person to ensure their recovery, rehabilitation and reintegration;

WHEREAS, Republic Act. No. 9262, underscores the commitment of the State on safeguarding the dignity of women and children while guaranteeing full respect of their human rights and to protect them from violence and threats to their personal safety and security;

WHEREAS, Joint Memorandum Circular No. 2010-1 of the Department of the Interior and Local Government (DILG), Department of Social Welfare and Development (DSWD) and Department of Justice (DOJ) provides for the creation of Local Committees on Anti-Trafficking and Violence against Women and Children;

WHEREAS, Section 13 of the IRR of RA 9208 and Section 59 of the IRR of RA 9262 further encourage the establishment and creation of mechanisms that shall facilitate the implementation of these laws at the local level.

NOW THEREFORE, I, **ARISTEO A. BALDOS, JR.**, Municipal Mayor by virtue of the powers vested in me by law, do hereby order the reconstitution of Municipal Committee in Anti-Trafficking and Violence against Women and their Children, as follows:

Section 1. COMPOSITION. The Municipal Committee on Anti-Trafficking and Violence against Women and their Children (MCAT-VAWC) shall be composed of the following:

Section 2. Functions of the Municipal Committee on Anti-Trafficking and Violence Against Women and their Children (MCAT-VAWC).

1. Institutes policies and programs to protect women and children who are victims of trafficking and violence;
2. Create and establish systems on surveillance, investigation and rescue to ensure effective and efficient coordination;
3. Undertake information, education and advocacy campaign against trafficking in person and VAWC;
4. Monitor and oversee the strict implementation of RA 9208, RA 9262 and other related laws for the protection of women and children and of the IACAT and IACVAWC national plans of actions; and
5. Implement the program and activities as stated in the national plan of action.

Section 3. REPORTING SYSTEM. The MCAT shall submit to the PCVAT a comprehensive report on the programs undertaken on a semestral basis every 15th of January and July of the following year.

Section 4. EFFECTIVITY. This Executive Order shall take effect immediately.
