EXECUTIVE ORDER NO. 23 -2022

AN ORDER RECONSTITUTING THE LOCAL HOUSING BOARD (LHoB) OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, DILG Memorandum Circular No. 2008-143 series of 2008 as amended by DILG Memorandum Circular No. 2009-05, provides guidelines for the creation of Local Housing Boards or similar bodies for all Local Government Units;

WHEREAS, there is a need for this Municipality to reorganize the Pinamalayan Municipal Housing Board in order to have a distinct policy-making organization that will be responsible on the observance of the right of the underprivileged and homeless to just and humane eviction and demolition.

NOW THEREFORE, I, **ARISTEO A. BALDOS, JR.**, Municipal Mayor by virtue of the powers vested in me by law, do hereby order the reconstitution of Local Housing Board (LHoB) of Pinamalayan, Oriental Mindoro, as follows:

Section 1. COMPOSITION. The Municipal Housing Board is shall be composed of the following:

Section 2. DUTIES AND FUNCTIONS. The council shall have the following functions:

- Policy Making – Preparation of Municipal shelter plans which shall form part of and are consistent with the municipal development plans
- Representational – the Board should delegate one representative to the Local Development Council.

- c. Technical Assistance – should assist the MDC in the formulation of Comprehensive Land Use Plan
- d. Ministerial – shall conduct inventory of all lands within the municipality and identify sites for socialized housing.
- e. Advisory/recommendatory- shall advise the Sangguniang Bayan on matters of local taxation, recommend sourcing of funds and formulate schemes for the acquisition and disposition of lands with the national government on housing for the underprivileged and homeless.
- f. Coordinate – shall coordinate with government agencies and instrumentalities performing functions which may affect housing and urban development.

Section 3. SECRETARIAT. The Municipal Social Welfare and Development Office (MSWDO) shall be the Secretariat of the Board.

Section 4. MEETING. The regular meeting shall be held every quarter or as often as may be deemed necessary.

Section 5. EFFECTIVITY. This Executive Order shall take effect immediately.
