EXECUTIVE ORDER NO. 24 -2022

AN ORDER RECONSTITUTING THE LOCAL NUTRITION COMMITTEE OF PINAMALAYAN, **ORIENTAL MINDORO**

WHEREAS, Republic Act No. 7160 has given the Local Government Units (LGUs) the power and authority to promote health and safety;

WHEREAS, the overall goal of Philippine Plan of Action for Nutrition (PPAN) 2017-2022 is the country's framework plan on nutrition is to contribute to the improvement of the quality of human resource in the country and reduce child and maternal mortality:

WHEREAS, DILG Memorandum Circular No. 2018-42 was issued on March 26, 2018 to provide guidelines on the roles and responsibilities of Local Government Units (LGUs) on the implementation of the PPAN 2017-2022;

WHEREAS, the nutrition program, being concerned with human resource development, is a vital and integral part of social reform and economic development;

WHEREAS, a functional local nutrition committee is critical to efficiently and effectively implement and manage the nutrition program

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor by virtue of the powers vested in me by law, do hereby order the reconstitution of Local Nutrition Council of Pinamalayan, Oriental Mindoro, as follows:

- 2. Generate and mobilize resources;
- 3. Integrate existing nutrition related projects and activities;
- 4. Revitalize the Barangay Nutrition Committees;
- 5. Coordinate the release of public funds for nutrition purposes in accordance with the approved projects and programs.

Section 3: MEETINGS. The Municipal Nutrition Committee shall meet once every quarter presided by the local chief executive or designated representative.

Section 4: EFFECTIVITY. This Executive Order shall take effect immediately.
