EXECUTIVE ORDER NO. 28 -2022

AN ORDER RECONSTITUTING THE SPECIAL DRUG EDUCATION CENTER TEAM (SDECT) OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, RA 9165, otherwise known as "Dangerous Drug Act of 2002" mandates the DILG in urging the LGUs to establish their respective Special Drug Education Centers (SDEC);

WHEREAS, the said center is tasked to implement drug abuse prevention program for Out-of-School Youths and street children;

WHEREAS, Memorandum Circular No. 2006-150 dated November 7, 2006 was issued by the Secretary of the Interior and Local Government directing LGUs to establish and operate their Special Drug Education Centers;

WHEREAS, local government units must pursue an intensive and unrelenting campaign against trafficking and use of dangerous drugs and other similar substances through an integrated system of planning, implementation and enforcement of anti- drug abuse policies, programs and projects;

NOW THEREFORE, I, ARISTEO A. BALDOS, JR. Municipal Mayor of Pinamalayan, Oriental Mindoro by virtue of the powers vested in me, do hereby establishment of the Special Drug Education Center of Pinamalayan, Oriental Mindoro with the composition of the Special Drug Education Center Team as follows:

Section 2. - RESPONSIBILITIES OF SDEC TEAM. The Team shall perform the following functions:

- Develop and implement programs and service on drug abuse prevention among the OSY and street children and coordinate/integrate/utilize related activities/services and other agencies;
- 2. Operate and manage the SDEC according to established guidelines set by the DSWD;
- Provide the facilities, funds, personnel, supplies, materials and equipment necessary in the management target clientele and manage their cases;
- 4. Identify target clientele and manage their cases;

Ensure that the SDEC complies with the standards developed on the operation of as an approved by the Dangerous Drugs Board (DDB);

- 6. Organize and mobilize volunteers to assist in the implementation of drugs abuse prevention program in coordination with the MSWDO;
- 7. Conduct regular monitoring and evaluation of the SDEC following the standards set, including documentation of the operation SEEC in the implementation of drug abuse prevention program;
- 8. Submit quarterly/annual reports to the Dangerous Drug Board, copy furnish the DSWD and DILG.

Section 3. SECRETARIAT. The Municipal Civil Registry shall serve as the Secretariat of the Team to be headed by *MR. ENRIQUE N. MOCLING*, OIC- Municipal Civil Registrar.

Section 4. MEETING. The Team shall meet at least once a month or as called by the team leader who will be responsible in setting the date, time and place of the meeting.

Section 5. FUNDING. The Municipal Government shall provide appropriate funds and administrative support necessary to defray expenses for the effective operation of the SDEC. Additional compensation and benefits shall NOT be given to the members of this council.

SECTION 6. EFFECTIVITY. The order shall take effect immediately.
