**EXECUTIVE ORDER NO. 32-2022**

**AN ORDER RECONSTITUTING THE LOCAL COUNCIL FOR CULTURE AND ARTS OF PINAMALAYAN, ORIENTAL MINDORO**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, Local Government Units shall prepare and implement programs that will promote culture and arts;

**WHEREAS**, DILG Memorandum Circular 2017-133 provides for the composition of Local Culture and Arts Council;

**WHEREAS**, there is a need to organize a council that will be responsible in carrying out programs and projects related to the protection, preservation, and promotion of cultural heritage and the ethnicity of local communities of the Municipality of Pinamalayan, Oriental Mindoro;

**NOW THEREFORE**, I, **ARISTEO A. BALDOS, JR.**, Municipal Mayor by virtue of the powers vested in me by law, do hereby order the reconstitution of Local Council for Culture and Arts of Pinamalayan, Oriental Mindoro, as follows:

**Section 2. DUTIES AND FUNCTIONS.** The Local Council for Culture and Arts shall have the following duties and functions:

1. Prepare an annual plan on culture, arts, and cultural heritage consonant with the Philippine Development Plan for Culture and the Arts, to be integrated in the local development plan and considered in the annual appropriation ordinances;
2. Formulate programs and recommendations to develop and sustain local cultural and artistic talents, cultural industries, traditional and contemporary arts and crafts, and their processes.

3. Coordinate with the appropriate affiliated cultural agencies of the national Commission for Culture and the Arts (NCCA) for the conservation and monitoring of national cultural properties found in the LGU;
4. Conduct cultural events such as cultural festivals, competition, lectures, seminars and symposia;
5. Identify such other programs and activities for the promotion of local heritage and arts;
6. Ensure the protection, preservation, conservation and promotion of the local cultural and historical heritage;
7. Declare and maintain Local Heritage Zones;
8. Establish a Local Registry of Cultural Property;
9. Acknowledge the importance of traditional folk artist as singular conduit between skills of the past and the future;
10. Revitalize a community's artistic tradition thereby protecting a valuable fact of the Philippine culture;
11. Provide mechanisms for identification and assistance for qualified tradition folk artists to transfer their skills to the community; and
12. Create opportunities for popularizing their works locally.

**Section 3. SECRETARIAT.** The Tourism, History, Culture and Arts Unit (THCAU) shall serve as the Secretariat of the Council.

**Section 4. EFFECTIVITY.** This Executive Order shall take effect immediately.
