**EXECUTIVE ORDER NO. 34 -2022**

**AN ORDER RECONSTITUTING THE MUNICIPAL COUNCIL FOR WOMEN OF PINAMALAYAN, ORIENTAL MINDORO**

**WHEREAS**, Section 14 of the Constitution provides that "the State recognizes the role of women in nation building, and shall ensure the fundamental equality before the law of women;

**WHEREAS**, in order to translate this Constitutional provision into action, the government has issued statutes enjoining women to participate actively and meaningfully at all levels of policy-making and governance;

**WHEREAS**, Presidential Proclamation No.774 dated December 06, 2004 provides that Local Chief Executives and other officials of local government units are hereby encouraged to implement plans, programs and activities geared towards the fulfillment of the human rights of women.

**WHEREAS**, DILG Memorandum Circular No. 2006-125 dated September 21, 2006 entitled "Amendment of DILG MC No. 2002-167 dated 10 October 2002 (Guidelines on the Procedures and Structures for the Creation of Local Councils of Women), mandates the organization of Local Councils of Women in every municipality.

**NOW THEREFORE**, I, **ARISTEO A. BALDOS, JR.**, Municipal Mayor by virtue of the powers vested in me by law, do hereby order the reconstitution of Municipal Council of Women of Pinamalayan, Oriental Mindoro, as follows:

**Section 1. COMPOSITION.** The Municipal Council for Women shall be composed of the following:

3. Work for the integration of the PFLCW, Inc. advocacy agenda and other relevant concerns in the provincial development plans and programs
4. Conduct meetings as the need arises
5. Coordinate, collaborate, recommend and provide the necessary support to NCRFW (now Philippine Commission on Women) and PFLCW, Inc. in the implementation of its programs

**Section 3. FUNDING.** The funds necessary to carry out this Order shall be sourced from the 5% budget for GAD as per mandated.

**Section 4. MONITORING AND REPORTING.** A quarterly report of all activities of Local Council for Women shall be given to the DILG Field Officer to be submitted to the DILG Provincial Office. Such report should reach the Provincial DILG Office not later than 25<sup>th</sup> of every end of the quarter.

**Section 5. EFFECTIVITY.** This Executive Order shall take effect immediately.
