EXECUTIVE ORDER NO. 37-2022

AN ORDER RECONSTITUTING THE PROJECT MONITORING COMMITTEE (PMC) OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Executive Order No. 325 Series of 1996 and DILG MC 2019-188 as provide for the creation of Project Monitoring Committee (PMC) at the provincial, city and municipal levels;

WHEREAS, there is a need to organize the PMC to monitor and evaluate the implementation of various local government projects funded from national government and local government funds including foreign assisted project/s whether grant or loan;

WHEREAS, the PMC in the execution of its duties and functions shall develop an overall Monitoring and evaluation system designed by National Economic Development Authority (NEDA).

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor, by virtue of the power vested in me by law do hereby order the reconstitution of the Project Monitoring Committee (PMC) of the Municipality of Pinamalayan, Oriental Mindoro, as follows:

Section 1. COMPOSITION. The PMC shall be composed of the following:

Section 2. SECRETARIAT. The Municipal Planning and Development Office shall serve as the Secretariat of the Project Monitoring Committee.

Section 3. DUTIES AND FUNCTIONS. The PMC shall perform the following duties ad functions:

- a. Provide the list and schedule of all projects to be monitored to NGOs involved in project monitoring;
- b. Collect and process reports of implementers and NGO monitors on the status of project implementation for the information of the LDC and next higher level PMC;
- c. Determine problems related to the implementation of programs and projects and verify information to be submitted for analysis and action of the LDC;
- d. Provide feedback on the remedial actions of the LDC and follow up implementation;
- e. Prepare and disseminate periodic project monitoring report on the status of project implementation to the Regional PMC (RPMC); and
- f. Elevate to higher level bodies (e.g. National PMC (NPMC), RPMC) issues and problems which are not resolved at the LPMC level.

Section 4. MEETING. The PMC shall hold a regular quarterly meeting to discuss the problems and issues affecting the implementation of various programs and projects and remedial actions to be elevated to the management committee;

Section 5. FUNDING. Funds for various PMC activities which include training, coordination, meetings, and preparation of reports among others shall be allocated by the local government to ensure the efficient operation of the committee.

Section 6. EFFECTIVITY. This Executive Order shall take effect immediately.
