EXECUTIVE ORDER NO. 038-2022

AN ORDER RECONSTITUTING THE MEMBERSHIP OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, RA6975 provides for the creation of at least one PLEB in every municipality;

WHEREAS, there is a need of organizing the People' Law Enforcement Board of the Municipality to hear complaints against any erring member of the Philippines National Police and impose the corresponding penalty;

WHEREAS, in the exercise of its function, the PLEB acting through its chairman is empowered to admit oaths, summon witness and required the production of documents as may necessary;

NOW, **THEREFORE**, **I**, **ARISTEO A. BALDOS**, **JR**. by virtue of the power vested in me by law do hereby order and direct the reorganization of the People's Law Enforcement Board (PLEB) of Pinamalayan, Oriental Mindoro as follows:

Section 1. COMPOSITION. The PLEB shall be composed of the following:

Section 2. POWERS AND DUTIES. The PLEB shall have the following powers and duties:

- 1. The PLEB shall have the power to hear and adjudicate all administrative complaints formally filed with or referred to, against any member of the PNP and to impose corresponding penalty;
- In the exercise of its functions, the PLEB acting through its chairman is empowered to administer oaths, summon, witness, require the production of subpoena duce's tecum and issue other processes as may be necessary;
- 3. Applying the provisions of Article 152 Chapter IV, Title III, Book I of the Revised Penal Code, the members of the PLEB are considered person in authority.

Section 3. TERM OF OFFICE. The term of office of the members of the PLEB shall be for a period of two (2) years from assumption of office. Such member shall hold office until his successor shall have been chosen and qualified.

The Board through the Municipal Peace and Order Council shall have its funding allocations to defray expenses especially in the preparation of documents.

SECTION 4. FUNDING. Funding may be provided by the Municipal Government to support the programs under the peace and order as it can be linked to Local Peace and Order and Public Safety Plan.

Section 5. EFFECTIVITY. This Executive Order shall take effect immediately.
