EXECUTIVE ORDER NO. 39-2022

AN ORDER DECLARING TEMPORARY CLOSURE OF PORTION OF JAENA STREET IN THE VICINITY OF THE MUNICIPAL PARK TO ACCOMMODATE THE SELLING OF GOODS, MERCHANDISE, FOODSTUFFS, COMMODITIES AND OTHER SIMILAR ARTICLES OF COMMERCE ON OCTOBER 7, 2022 TO DECEMBER 31, 2022

WHEREAS, pursuant to Republic Act No. 7160, any municipality may temporarily close and regulate the use of any local street, road, thoroughfare, or public place where shopping malls, Sunday markets, flea or night markets, or shopping areas may be established and where goods, merchandise, foodstuff, commodities, or articles of commerce may be sold and dispensed to the general public;

WHEREAS, the Local Chief Executive was authorized by the Sangguniang Bayan to temporarily close a portion of Jaena Street thru Sanggunian Bayan Ordinance No. 01-2017 dated March 6, 2017;

WHEREAS, the Municipal Government of Pinamalayan acknowledges the significance of night market in the sustainable and comprehensive economic growth and social progress of the municipality.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR, Local Chief Executive of the Municipality of Pinamalayan, by virtue of the powers vested in me by law do hereby order the temporary closure of portion of Jaena Street in the vicinity of the Municipal Park to accommodate the selling of goods, merchandise, foodstuffs, commodities and other similar articles of commerce on October 7, 2022 to December 31, 2022.

SECTION 1. SCOPE. Both sides of Jaena Street from corner Madrid Blvd. to corner Mabini Street in the vicinity of Municipal Park shall be closed to accommodate the selling of goods, merchandise, foodstuffs, commodities and other similar articles of commerce.

Section 2. DURATION. The temporary closure of portion of Jaena Street shall take effect on October 7, 2022 to December 8, 2022 and December 17-31, 2022, every Friday, Saturday and Sunday only and for the entire period of December 9 to 16, 2022, from 3:00 o'clock in the afternoon to 12:00 o'clock midnight.

SECTION 3. TERMS AND CONDITIONS. The following terms and conditions shall be implemented:

- a. That a substitute route with corresponding routing plan shall be provided;
- b. That the alternate route shall be properly maintained for public safety until such duration that the subject road will be opened back to the public;
- c. That the residents of the area covered by the closure of road shall be given access;
- d. That all relevant laws and department orders appertaining temporary closure of roads and its guidelines shall be strictly followed.

SECTION 4. SUPERVISION. The Tourism, History, Culture and Arts Unit (THCAU) and the Local Economic Development and Investment Promotion Office (LEDIPO) shall see to it that safety health protocols such as wearing of facemasks and social distancing are strictly observed. The THCAU and LEDIPO shall also take charge of the public announcement informing the public that the aforementioned road is subject for temporary closure and stating the specific day and time.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately.

ORDINANCE NO. 01 - 2017

AN ORDINANCE DECLARING THE TEMPORARY CLOSURE TO VEHICULAR TRAFFIC THE PORTIONS OF STREETS IN THE POBLACION WITH THE SPECIFIC ACTIVITY AND DURATION PURSUANT TO ARTICLE 45, RULE VIII OF THE RULES AND REGULATIONS IMPLEMENTING THE LOCAL GOVERNMENT CODE OF 1991.

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro, that:

Section 1. TITLE - This Ordinance shall be known as Ordinance declaring the temporary closure to vehicular traffic the portions of streets in the poblacion with the specific activity and duration pursuant to Article 45, Rule VIII of the Rules and Regulations Implementing the Local Government Code of 1991.

Section 2. DECLARATION OF POLICY – The enactment of this ordinance is anchored in Rule VIII, Article 43, of Rules and Regulations Implementing the Local Government Code of 1991, "Authority to Close or Open", an LGU may, through an ordinance, permanently or temporarily close or open any road, alley, park or square within its jurisdiction and Article 45. "Temporary Closure" a) Any national or local road, alley, park or square may be temporarily closed during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs, or undertaking of public works and highways, telecommunications and waterworks projects, the duration of which shall be specified by the Local Chief Executive concerned in a written order, x x x.

Section 3. PURPOSE - The temporary closure of portions of streets in the poblacion shall be temporarily utilized as an space to accommodate the Baraklan and vendors during the period of fiesta celebration which shall be designed and approved to ensure the protection and safety of the constituents who will be going on these places.

Section 4. SCOPE – An authority to the Local Chief Executive is hereby given for temporary closure of Westbound road shoulder portion of Madrid Boulevard (From Jaena to Leuterio Streets); full road portion of Jaena Street (Between Madrid Blvd. and Mabini St.); Eastbound road shoulder portion of Mabini St. (From Leuterio to Jaena Streets); and full road portion of Leuterio Street (Between Madrid Blvd. and Mabini St.) of the Municipality of Pinamalayan, Oriental Mindoro for the duration of yearly town fiesta celebration or the Municipality's founding anniversary to be temporarily utilized as an space to accommodate the Baraklan and vendors which are traditionally established during the period of fiesta celebration.

Section 5. EFFECTIVITY - This Ordinance shall take effect upon its approval.

ENACTED this 6th day of March 2017 at Pinamalayan, Oriental Mindoro on motion of Hon. Arnoldo M. Madrid and duly seconded by Hon. Norman J. Jacinto, said Ordinance was UNANIMOUSLY APPROVED.
