EXECUTIVE ORDER NO. 40 -2022

AN ORDER RECONSTITUTING THE MUNICIPAL TRAINING TEAM FOR STRENGTHENING INSTITUTIONAL CAPACITIES OF BARANGAY ANTI-DRUG ABUSE COUNCIL (SICAP – BADAC) OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Section 16 or the General Welfare Clause of the Local Government Code of 1991, provides that Local Government Units shall, within their jurisdictions, promote health and safety, improve public morals, maintain peace and order and preserve the comfort and convenience of their inhabitants, among other equally significant responsibilities;

WHEREAS, the use of illegal drugs has significantly contributed to the high incidence of heinous crimes and the ill effects of illegal drugs is quite alarming in the peace and order situation of the community;

WHEREAS, addressing the illegal drug problem is a shared responsibility of the national and local government units, in collaboration with the various sectors of the society;

WHEREAS, there is a need to reorganize SICAP-BADAC to add mandatory member as per DILG Memorandum dated September 16, 2022 and to replace members who are no longer connected to the agency.

NOW THEREFORE, I, ARISTEO A. BALDOS, JR. Municipal Mayor of the Pinamalayan, Oriental Mindoro by the powers vested in me by law do hereby order the reconstitution of the of the Municipal Training Team for Strengthening Institutional Capacities of Barangay Anti-Drug Abuse Council (SICAP – BADAC) of Pinamalayan, Oriental Mindoro as follows;

2. Conduct roll-out training to the Barangay Anti-Drug Abuse Councils (BADACs) and equip them with the necessary knowledge, skills and attitude to efficiently perform their duties and functions in relation to:
 - (a) Barangay Drug Clearing Program;
 - (b) Drug Prevention Program;
 - (c) Community-Based Drug Rehabilitation program; and
 - (d) Aftercare and Reintegration Program
 3. Conduct roll-out training and submit Post Activity Report/After Activity Report to DILG Provincial Office;
 4. Perform other duties and functions as may be deemed necessary.

Section 3. EFFECTIVITY. This Executive Order shall take effect immediately.
