#### **EXECUTIVE ORDER NO. 47-2022**

AN ORDER PROVIDING FOR THE ESTABLISHMENT AND REGULATIONS OF NIGHT MARKET IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

**WHEREAS**, the Municipal Government of Pinamalayan encourages the engagements of Micro Enterprises to spur local economic activities for the optimization of its revenue-raising capacity;

WHEREAS, Article X, Section 56 of Municipal Ordinance No. 13-2020 otherwise known as the Pinamalayan Traffic Management and Enforcement Code authorizes the Local Chief Executive to temporary close roads any municipal roads/streets, thoroughfares or any public place for the purposes of establishing shopping stalls, Sunday flea or night markets or tiange, Christmas Bazar and Baraklan;

**WHEREAS**, the Local Economic Development and Investment Promotion Office (LEDIPO) recommended the portion of Jeana Street as temporary venue of Pinamalayan Night Market;

WHEREAS, the Municipal Government of Pinamalayan affirms the significance of establishing night market as an avenue for the micro enterprises to promote their product towards sustainable and comprehensive economic growth and social progress of the municipality.

**NOW, THEREFORE, I, ARISTEO A. BALDOS, JR**, Local Chief Executive of the Municipality of Pinamalayan, by virtue of the powers vested in me by law do hereby promulgate this Order, as follows:

**Section 1. POLICY.** The Municipal Government of Pinamalayan supports the policies of the State to promote the welfare of the public by providing sufficient windows for economic gains; attain inclusive socio-economic development through advancing the interests of microentrepreneurs and generation of employment opportunities; and, maximize the utilization of government assets for sustainable and comprehensive economic growth and social progress.

Section 2. LOCATION OF THE NIGHT MARKET. the Municipal Government of Pinamalayan designates and declares legally portion of Jaena Street from corner Madrid Blvd to corner Mabini Street.for purpose of the night market as authorized under Article X, Section 56 of Municipal Ordinance No. 13-2020 or the Pinamalayan Traffic Management and Enforcement Code.

**Section 3. DESIGNATED DAYS OF NIGHT MARKET**. The days of the Night Market shall be Fridays, Saturdays and Sundays from December 8, 2022 and December 17-31, 2022 and Monday to Friday from December 9 to 16, 2022. Installing of the paraphernalia shall be at 2:00 PM, closing time shall be at 12:00 midnight. Night market shall be for duration of nine (9) hours.

Section 4. APPLICATION REQUIREMENTS. Night Market is open to all Small Medium Enterprises (SMEs) upon submission of Letter of Intent, Barangay Business Clearance and Health Clearance applicable to Food Stall owners/staff

Section 5. STALL ASSIGNMENT - Upon approval of their applications, occupants in the night market shall be assigned to a location by the Local Economic and Investment Promotion (LEDIP) Officer. Occupants are committed to sell their wares/open for business during all Fridays, Saturdays and Sundays within the period specified in this Order. Failure to abide with this condition shall be sufficient cause for the withdrawal of the allotted stall space, hence, the Municipal Government of Pinamalayan is entitled to award his/her space to another applicant.

Each occupant is only allowed to occupy a maximum of four (4) square meter-stall (2 x 2) with blue color.

Section 6. INSTALLATION AND ALLOWABLE GOODS FOR DISPLAY AND VENDING. Only light structures and materials which could be easily folded, lifted and removed should be installed since the stay of the occupants is limited and temporary. The Municipal Government if deemed necessary shall provide the design of collapsible structure and shall regulate the same to observe safety and aesthetics.

Occupants can only install and display their goods and other market paraphernalia within their designated area. Failure to comply shall be grounds for the removal of the displayed goods by the Pinamalayan Municipal Police

The following items which belong to the following categories are prohibited: a. Pirated materials, such as DVDs and CDs; b. Livestock and poultry, either butchered or alive c. Goods and services that emit loud noise and require heavy electrical load (more than 500 watts), d. Alcoholic Drinks.

Section 7. SELLING OF GOODS AND SERVICES. Occupants and their respective sales personnel and helpers must wear an identification card duly issued by the Municipal Government of Pinamalayan when they are in the premises of the night market and are actively involved in the selling of their wares or services. The size of identification card shall be 4 x 5 inches with the picture and name of the bearer clearly legible. The Local Economic Development and Investment Promotion Office (LEDIPO) and Tourism, History, Culture and Arts Unit (THCAU) shall determine the design and the other necessary information needed to be written on the ID.

Section 8. REMOVALOF GOODS AND COMMERCIAL PARAPHERNALIA. All materials installed and/or displayed at the night market must be completely removed and cleared on or before closing time. No structures, paraphernalia and goods of any part shall be left within the site of the night market site, along any streets, road-right-of-ways and/or in any publicly-owned sites.

Section 9. RESPONSIBILITY OF THE OCCUPANTS. It is the duty and obligation of the occupants to maintain the cleanliness and sanitation of their premises.

For convenient collection by garbage trucks, occupants are hereby obliged to observe proper segregation of solid waste and to place their garbage in separate disposable containers, properly labeled either 'biodegradable' or 'non-biodegradable' and orderly kept at the side of the gutter of the road with their top openings tied or sealed to avoid scattering or spillage. No solid waste shall be thrown in the drainage canals situated inside or in the surroundings of the night market. To avoid foul odor and unclean surroundings, occupants must maintain dryness of their respective areas. Liquid waste must be placed in a separate container, which shall be properly labeled "liquid waste" and orderly kept at the side of the gutter of the road with its top opening tied or sealed to avoid spillage.

Section 10. ASSIGNMENT OF SECURITY OFFICERS. While it is understood that occupants are to avoid unruly behavior, the Municipal Government of Pinamalayan, however, shall assign Traffic Management Officers and other deputized peace officers to the night market for the purpose of maintaining the security and peace and order of the place. Assistance of the members of the Philippine National Police shall be called whenever necessary.

Section 11. REPEALING CLAUSE. All orders and regulations or parts thereof contrary to or inconsistent with any of the provisions of this Order are hereby repealed.

Section 12. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately upon its approval.
