**Invitation to Bid**  
**ITB-2021-21**

1. The Municipal Government of Pinamalayan, Oriental Mindoro, through the authorized appropriations under the **General Fund -Loan** intend to apply the sum of **Thirty Three Million Two Hundred Fourteen Thousand Seven Hundred Thirty One Pesos and Forty Eight Centavos (33,214,731.48)** being the Approved Budget for the Contract (ABC) for the Project **“Road Reblocking Brgy. Guinhawa –Sta. Isabel-Buli & Pola Boundary Roads”**.

Attachment Annex A for Technical Specification shall form part of ITB 2021-21

Bids received in excess of the ABC shall be automatically rejected a bid opening.

2. Bidders/Contractors must meet the following major requirements; (a) Filipino Citizen or 75% Filipino-owned partnership/corporation with PCAB License for Size Range **Medium A** (b) Should have completed within the last three (3) years from the date of submission and receipt of bids at least one (1) contract similar to the Project and whose value must be at least fifty percent (50%) of the Approved Budget for the Contract (ABC), and (c) Net Financial Contracting Capacity at least equal to the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section 5, Instruction to Bidders.

Contractor/applicants who wish to participate in this bidding are encouraged to enrol in the Bids and Awards Committee (BAC) at BAC Office, Manpower Development Center 2<sup>nd</sup> Floor, Municipal Compound, while those already enrolled shall keep their records current and updated. The Contractor's eligibility to bid on the project will be determined using the BAC Eligibility Profile process and subject to further post-qualification Information on registration can be obtain from BAC Office during working weekdays from 8:00 am to 5:00pm or at the agency's website.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the “Government Procurement Reform Act”.

4. Bid Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee amounting to Php **33,715.00** for the Bidding Documents.
