EXECUTIVE ORDER NO. 10-2023

AN ORDER IDENTIFYING THE COMPOSITION OF MUNICIPAL COMMITTEE ON ANTI-TRAFFICKING, AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (MCAT-VAWC) AND ITS SECRETARIAT OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, the Municipal Committee in Anti-Trafficking and Violence against Women was reconstituted by virtue of Executive Order No. 21-2022 issued by the Local Chief Executive on September 30, 2022;

WHEREAS, there is a need to identify Civil Society Organization (CSO) representatives in the committee and its secretariat as well as the additional functions of the committee.

As additional function, MCAT VAWC shall coordinate with Regional and National Committees on Anti-Trafficking and Violence Against Women and their Children on any course of action that may facilitate measures to:

- 1. Prevent trafficking and VAWC;
- 2. Properly administer the comprehensive rehabilitation and reintegration of victims of trafficking and VAWC.
- **Section 3. MEETING AND QUORUM.** The Committee shall meet at least once every quarter or as often as ay be necessary. Majority of all its members shall constitute a quorum.
- **Section 4. SECRETARIAT.** The MSWDO shall serve as the Secretariat of MCAT-VAWC and shall be responsible for the documentation of proceedings of meetings, preparation of reports, and other necessary documents as needed by the Committee.

Section 5. EFFECTIVITY. This Executive Order shall take effect immediately.
