EXECUTIVE ORDER NO. 11-2023

AN ORDER AMENDING SECTIONS 1 AND 2 OF EXECUTIVE ORDER NO. 37-2022 ENTITLED "AN ORDER RECONSTITUTING THE PROJECT MONITORING COMMITTEE (PMC) OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO"

WHEREAS, Executive Order No. 325 Series of 1996 and DILG MC 2019-188 provide for the creation of Project Monitoring Committee (PMC) at the provincial, city and municipal levels;

WHEREAS, the Project Monitoring Committee of the Municipality of Pinamalayan, Oriental Mindoro was reconstituted by virtue of Executive Order No. 37-2022 issued by the Local Chief Executive on September 30, 2022;

WHEREAS, in compliance with Republic Act No. 7160 Article 3 Section 3, said executive order was indorsed to Provincial Governor's Office for review;

WHEREAS, upon review and evaluation of Provincial Legal Office (PLO), there is a need to comply with the comments and recommendations forwarded by the Provincial Governor's Office to the Municipal Government of Pinamalayan prior to the issuance of Certificate of Legality.

WHEREAS, there is a need to amend the composition of the Project Monitoring Committee to include nominees from the Municipal Development Council (MDC) as regular members of the committee.

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Local Chief Executive of the Municipality of Pinamalayan, Province of Oriental Mindoro, by virtue of power vested in me by law, do hereby order the amendment in Sections 1 and 2 of Executive Order No. 37-2022, as follows:

Section 1. AMENDMENT ON SECTION 1 OF EXECUTIVE ORDER NO. 37-2022. Section 1 of Executive Order No. 37-2022 is hereby amended to read as follows:

- a. Prepare the monitoring and evaluation (M&E) work program to be undertaken by the PMC during any given fiscal year which will include the list of the projects and schedule of implementation based on submission of implementing agencies:
 - b. Provide the Local Chief Executive with information on the projects to be monitored by the PMC; and
 - c. Facilitate inter-agency, inter-governmental, and field headquarters coordination, if necessary”

Section 3. EFFECTIVITY. This Executive Order shall take effect immediately.
