**EXECUTIVE ORDER NO. 02 -2023**

**AN ORDER IDENTIFYING THE COMPOSITION OF THE MUNICIPAL LOCAL COMMITTEE AGAINST SQUATTING SYNDICATES AND PROFESSIONAL SQUATTERS (LCASSPS) OF PINAMALAYAN, ORIENTAL MINDORO**

**WHEREAS**, the Department of Interior and Local Government Memorandum Circular No. 2012-04 directs all the City, Municipal Mayors and Members of Sanggunian and DILG Regional Directors to create a Local Committees Against Squatting Syndicate and Professional Squatters (LCASSPS) and /or similar bodies.

**WHEREAS**, the Local Committee against Squatting Syndicates and Professional Squatters (LCASSPS) of Pinamalayan, Oriental Mindoro was reconstituted by virtue of Executive Order No. 31-2022 issued by the Local Chief Executive on September 30, 2022;

**WHEREAS**, there is a need to identify the names of National Government Agencies (NGAs) Representatives that will sit as regular members of the committee.
