#### **EXECUTIVE ORDER NO. 03-2023**

AN ORDER AMENDING SECTIONS 1 AND 4 OF EXECUTIVE ORDER NO. 36-2022 ENTITLED "AN ORDER RECONSTITUTING THE LOCAL SCHOOL BOARD (LSB) OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO IDENTIFYING ITS MEMBERS, THEIR DUTIES AND FUNCTIONS AND OTHER PURPOSES"

WHEREAS, Article 184 of the Implementing Rules and Regulations of the Local Government Code of 1991 (Republic Act 7160) mandates the creation of the Local School Board (LScB);

WHEREAS, the Local School Board (LScB) of Pinamalayan, Oriental Mindoro was reconstituted by virtue of Executive Order No. 36-2022 issued by the Local Chief Executive on September 30, 2022;

WHEREAS, in compliance with Republic Act No. 7160 Article 3 Section 3, said executive order was indorsed to Provincial Governor's Office for review;

**WHEREAS**, upon review and evaluation of Provincial Legal Office (PLO), there is a need to comply with the comments and recommendations forwarded by the Provincial Governor's Office to the Municipal Government of Pinamalayan prior to the issuance of Certificate of Legality.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR, Local Chief Executive of Municipality of Pinamalayan, Oriental Mindoro, in consideration of the findings and recommendations of the Provincial Legal Office, do hereby order the amendment of Sections 1 and 4 of Executive Order No. 36-2022, as follows:

Section 2. PROHIBITION FROM DELEGATION. Consistent with Article 184 of the Implementing Rules and Regulations of the Local Government Code of 1991 (Republic Act 7160), paragraph (d), the performance of the duties and responsibilities of the officials mentioned in Section 1 of this Order shall not be delegated.

Section 3. AMENDMENT ON SECTION 4 OF EO NO. 36-2022. Section 4 of Executive Order No. 36-2022 is hereby amended to read as follows:

> "Section 4. BUDGET. The district supervisor shall prepare the budget of the school board concerned. Such project shall be supported by programs, projects and activities of the school board for the ensuing fiscal year. A majority of all the members shall be necessary to approve the budget. The annual school board budget shall give priority to the following:

- a) Construction, repair, and maintenance of school buildings and other facilities of public elementary and secondary schools;
- b) Establishment and maintenance of extension classes where necessary; and
- c) Holding of Sports activities at the division, district, municipal, and barangay levels."

Section 4. EFFECTIVITY. This Executive Order shall take effect immediately.
