EXECUTIVE ORDER NO. 06-2023

AN ORDER EXPANDING THE COMPOSITION OF THE MUNICIPAL COUNCIL FOR WOMEN OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Presidential Proclamation No. 774 dated December 06, 2004 provides that Local Chief Executives and other officials of local government units are hereby encouraged to implement plans, programs and activities geared towards the fulfillment of the human rights of women.

WHEREAS, DILG Memorandum Circular No. 2006-125 dated September 21, 2006 entitled "Amendment of DILG MC No. 2002-167 dated 10 October 2002 (Guidelines on the Procedures and Structures for the Creation of Local Councils of Women)", mandates the organization of Local Councils of Women in every municipality;

WHEREAS, the Local Council for Women of Pinamalayan, Oriental Mindoro was reconstituted by virtue of Executive Order No. 34-2022 issued by the Local Chief Executive on September 30, 2022;

WHEREAS, it is necessary to expand the composition of Municipal Council for Women to include representatives from Local Government Unit and Civil Society Organizations (CSOs) that will sit as regular members of the council.

NOW THEREFORE, I, **ARISTEO A. BALDOS, JR.**, Municipal Mayor by virtue of the powers vested in me by law, do hereby order the expansion of the composition of Municipal Council of Women of Pinamalayan, Oriental Mindoro, as follows:
