EXECUTIVE ORDER NO. 08-2023

AN ORDER IDENTIFYING THE COMPOSITION OF MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN (MCPC) OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, DILG Memorandum Circular No. 2021-039 entitled, "Comprehensive Guidelines for the Establishment, Strengthening, and Monitoring of the Local Council for the Protection of Children (LCPC) at all Levels and for Other Purposes", dated 07 April 2021 mandates all local chief executives and Sanggunians at the provincial, city, municipal and barangay levels to organize/reorganize the LCPCs to assist the LGU in the identification, implementation, and monitoring of programs, projects and activities for the protection of children in their respective localities;

WHEREAS, the Municipal Council for the Protection of Children (MCPC) of the Municipality of Pinamalayan, Oriental Mindoro was reconstituted by virtue of Executive Order No. 22-2022 dated September 30, 2022;

WHEREAS, there is a need to identify the name of the parent and the child representatives in the composition of the Council.

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor of Pinamalayan, Oriental Mindoro by virtue of the powers vested in me by law, do hereby order the identification of the composition of Municipal Council for the Protection of Children of Pinamalayan, Oriental Mindoro as follows:
