EXECUTIVE ORDER NO. 09-2023

AN ORDER IDENTIFYING THE COMPOSITION OF MUNICIPAL PRICE COORDINATING COUNCIL (MPCC) OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, the RA 10623 states that the policy of the State to ensure the availability of basic necessities and prime commodities at reasonable prices at all times without denying legitimate business a fair return on investment;

WHEREAS, the Municipal Price Coordinating Council was reconstituted by virtue of Executive Order No. 25-2022 issued by the Local Chief Executive on September 30, 2022;

Section 2. DUTIES AND FUNCTIONS. The MPCC shall perform duties and functions provided in Section 2 of Executive Order No. 25-2022.

Section 3. SECRETARIAT. The Business Permit and Licensing Office (BPLO) shall serve as the Secretariat of LPCC and shall be responsible for the documentation of proceedings of meetings, preparation of reports, and other necessary documents as needed by the council.

Section 4. EFFECTIVITY. This Executive Order shall take effect immediately.
