**EXECUTIVE ORDER 17-2023**

**AN ORDER CREATING THE MUNICIPAL FISHERIES AND AQUATIC RESOURCES MANAGEMENT COUNCIL (MFARMC) IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO**

**WHEREAS**, Republic Act 7160, otherwise known as Local Government Code of 1991, mandates the local government unit to adopt measures to protect the coastal and marine environment within their respective jurisdiction;

**WHEREAS**, Republic Act 8550 or the Philippine Fisheries Code of 1998, similarly mandates the local government units to enforce laws and regulations relative to the protection of the coastal and marine resources;

**WHEREAS**, for an effective and efficient protection, conservation, development, management, and sustainable utilization of the coastal and fishery resources, the active participation of stakeholders in the planning and implementation of fishery development programs shall be encouraged;

**WHEREAS**, there is a need to create Municipal Fisheries and Aquatic Resources Management Council to ensure the stability and continuity in enforcing and implementation of fishery related programs, laws and ordinances.

**NOW, THEREFORE, I, ARISTEO A. BALDOS, JR.**, Local Chief Executive of Municipality of Pinamalayan, by virtue of the powers vested in me by law, do hereby order the creation of Municipal Fisheries and Aquatic Resources Management Council, as follows:

**Section 2. DUTIES AND FUNCTIONS.** The MFARMC shall perform the following duties and functions;

1. Assist in the preparation of the Municipal Fishery Development Plan and submit such plan to the Municipal Development Council;
2. Recommend the enactment of the Municipal Fishery Ordinance to the Sanggunian through its Committee on Fisheries;
3. Assist in the enforcement of fishery laws, rules and regulations in the Municipal Waters;
4. Advice the Sanggunian of fishery matters, through its Committee on Fisheries; and
5. Perform such other functions as may be assigned by the Sanggunian

**Section 3. SECRETARIAT.** The Municipal Agriculture Office (MAgO) shall serve as the focal office or Secretariat of the Municipal Fisheries and Aquatic Resources Management Council and shall be responsible for the documentation of proceedings of meetings, preparation of reports, and other necessary documents as needed by the council.

**Section 4. EFFECTIVITY.** This Executive Order shall take effect immediately.
