EXECUTIVE ORDER NO. 20-2023

AN ORDER CREATING THE NIGHT MARKET COMMITTEE IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Municipal Ordinance No. 04-2023 enacted by the Sangguniang Bayan on March 6, 2023 provides for the establishment and regulating of Night Market in the Municipality of Pinamalayan, Oriental Mindoro;

WHEREAS, Article VII, Section 1 of aforesaid ordinance mandates the creation of Night Market Committee:

WHEREAS, the Municipal Government of Pinamalayan encourages the engagements of Micro Enterprises to spur local economic activities for the optimization of its revenue-raising capacity and affirms the significance of establishing night market as an avenue for the micro enterprises to promote their product towards sustainable and comprehensive economic growth and social progress of the municipality;

WHEREAS, the creation of Night Market Committee is necessary for the effective implementation of various policies and issuances for effective monitoring and safeguarding of night market operation.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR, Local Chief Executive of Municipality of Pinamalayan, by virtue of the powers vested in me by law, do hereby order the creation of Night Market Committee in the Municipality of Pinamalayan, Oriental Mindoro, as follows:

Section 2. DUTIES AND FUNCTIONS. The Night Market Committee shall perform the following duties and functions:

- 1. The Committee shall be the main implementer of the ordinance;
- 2. Formulate local issuances, memoranda, and circulars for effective monitoring and safeguarding of night market operation;
- 3. Apprehend violators in accordance with the ordinance;
- 4. Disseminate information, guidelines and memoranda to stakeholders;
- 5. Regularly submit reports to the Local Chief Executive on the status of its activities;
- 6. Conduct regular monitoring and surveillance of day-to-day operations; and
- 7. Perform such other functions as may be necessary for the full and proper implementation of the ordinance.

Section 3. SECRETARIAT. The Local Economic Development and Investment Promotion Office (LEDIPO) shall serve as secretariat of the Committee to be headed by MR. JOHN DAVE M. DELOS SANTOS, LEDIP Officer. The Secretariat shall be responsible in providing technical and administrative support, documentation of the proceedings, preparation of indorsements, letters, contracts and such other services as may be deemed useful in the discharge of its functions.

Section 4. EFFECTIVITY. This Executive Order shall take effect immediately.
