EXECUTIVE ORDER NO. 24-2023

AN ORDER AUTHORIZING THE MUTUAL USE AND CO-SHARING OF MUNICIPAL OPERATION CENTER OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (MDRRMO) AND MUNICIPAL HEALTH OFFICE (MHO) DURING DISASTERS, CALAMITIES AND MEDICAL EMERGENCIES FOR THE INSTITUTIONALIZATION OF DISASTER RISK REDUCTION AND MANAGEMENT IN HEALTH (DRRM-H)

WHEREAS, the Section 4 of Republic Act No. 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2020 provides for the development of policies and plans and the implementation of actions and measures pertaining to all aspects of disaster risk reduction and management including good governance, risk assessment and early warming knowledge building and awareness raising, reducing underlying risk factors and preparedness for effective response and early recovery;

WHEREAS, the Department of Health Administrative Order No. 29 series 2022 establishes principles and recommendations for the development of Operation Centers at all levels to guarantee a well-coordinated response to the health sector;

WHEREAS, the Municipality of Pinamalayan is at risk to all disaster, calamities and various health emergency and the need of Municipal Heath Office personnel at frontline providing safe, effective and efficient health services to the affected population;

WHEREAS, in order to ensure a secure and efficient coordination and response during disasters, calamities, and various health emergencies, it is also necessary to include and integrate the Health Emergency Response Team in the planning and operations of the emergency response unit. This allows for the mutual use of our resources, particularly its facilities and human resources.

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Local Chief Executive of the Municipality of Pinamalayan, Province of Oriental Mindoro, by the virtue of power vested in me by law, do hereby order the Mutual use and Co-sharing of Municipal Operation Center of the Municipal Disaster Risk Reduction and Management Office (MDDRMO) and Municipal Health Office (MHO) during disasters, calamities and medical emergencies for the institutionalization of Disaster Risk Reduction and Management in Health (DRRM-H).

This Order shall take effect immediately and shall remain effective unless otherwise revoked or modified.
