#### **EXECUTIVE ORDER NO. 27-2023**

AN ORDER CREATING SPECIAL BODY THAT WILL STUDY THE QUALITY, STATUS AND CONDITION OF WATER SUPPLY WITHIN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Section 16 of the Local Government Code of 1991 states that "every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

**WHEREAS,** Sangguniang Bayan Resolution No. 096-2023 dated April 3, 2023 recommends the creation of Special Body that will study the quality, status and condition of water supply within the Municipality of Pinamalayan;

**WHEREAS,** the quality, status and condition of all water sources in the Municipality of Pinamalayan should be regularly monitored and analyzed to promote public health as one of the fundamental aspects of primary health care;

**WHEREAS**, the creation of said Special Body is necessary to redress the longstanding concern on alleged poor quality of water within the Municipality of Pinamalayan.

**NOW, THEREFORE, I, ARISTEO A. BALDOS, JR,** Local Chief Executive of Municipality of Pinamalayan, by virtue of the powers vested in me by law, do hereby order creation of Special Body that will study the quality, status and condition of water supply within the Municipality of Pinamalayan, Oriental Mindoro, as follows:

Section 2. DUTIES AND FUNCTIONS. The Special Body perform the following duties and functions:

- 1. Study and formulate measures that will lead to a decent water supply within the Municipality of Pinamalayan;
- 2. Serve as focal point of correspondence dialogues, and other measures for the advancement of water supply in the municipality;
- 3. Identify areas for development and provide recommendations to enhance access and provision of safe and good quality water to constituents;
- 4. Evaluate the performance of Water Service Providers in terms of providing quality, adequate, affordable and continuous supply of safe water;
- 5. Attend capacity development activities;
- 6. Conducts regular quarterly meeting or as the need arises; and
- Perform other duties and functions that may deemed necessary.

Section 3. BUDGETARY SUPPORT AND FUNDING. Funds needed such as but not limited to administrative cost, capability building and other expenses needed by the Special Body in the discharge of its functions shall be made available from the General Fund.

Section 4. EFFECTIVITY. This Executive Order shall take effect immediately.
