EXECUTIVE ORDER NO. 29-2023

AN ORDER CREATING THE MUNICIPAL TASK FORCE KNOWN AS "BANTAY KARNE" IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, the Local Government Code or the Republic Act No. 7160 requires the provincial, municipal, and city governments to regulate the preparation and sale of meat for public consumption while the Code of Sanitation of the Philippines or the Presidential Decree No. 856) provides for the sanitary requirements in the operation of markets;

WHEREAS, the Meat Inspection Code of the Philippines or the Republic Act No. 9296 requires the National Meat Inspection Services to provide regulations to ensure the safety, quality and wholesomeness of meat and meat products;

WHEREAS, the Municipal Ordinance No. 01-2023 enacted by the Sangguniang Bayan on February 13, 2023 provides for the regulation of sale, transport and handling of meat in meat markets in the Municipality of Pinamalayan;

WHEREAS, Section 16 of the aforementioned Ordinance mandates the creation of Municipal Task Force known as "Bantay Karne";

WHEREAS, the creation of the Municipal Task Force "Bantay Karne" is necessary to oversee the implementation of aforesaid municipal ordinance and other related activities as may be provided by rules and regulations and guidelines promulgated by higher authority or mandated by the national laws.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR, Local Chief Executive of Municipality of Pinamalayan, by virtue of the powers vested in me by law, do hereby order the creation of Municipal Task Force known as "Bantay Karne" in the Municipality of Pinamalayan, Oriental Mindoro, as follows:

Section 2. DUTIES AND FUNCTIONS. The Municipal Task Force or the "Bantay Karne" shall perform the following duties and functions:

- 1. The Taskforce shall be the main implementer of Municipal Ordinance No. 01-2023;
- 2. Formulate local issuances, memoranda, and circulars for effective monitoring and safeguarding of meat handling, sales and distribution;
- 3. Apprehend violators in accordance with the Municipal Ordinance No. 01-2023;
- 4. Disseminate information, guidelines, and memoranda to all stakeholders;
- 5. Regularly submit reports to the Local Chief Executive on the status of its activities;
- 6. Conduct regular monitoring and surveillance of day-to-day operations; and
- 7. Perform such other functions as may be deemed necessary.

Section 3. SECRETARIAT. The Slaughterhouse Operations Division shall serve as the secretariat of the Taskforce to be headed by MS. ANNE MARIELLE G. ABRENICA, Administrative Officer II. The Secretariat shall be responsible in providing technical and administrative support, documentation of the proceedings, preparation of indorsements, letters, contracts and such other services as may be deemed useful in the discharge of its functions.

Section 4. EFFECTIVITY. This Executive Order shall take effect immediately.
