EXECUTIVE ORDER NO. 45-2023

AN ORDER ACTIVATING THE MUNICIPAL INCIDENT COMMAND SYSTEM AND EXPANDING THE COMPOSITION OF AFRICAN SWINE FEVER (ASF) TASK FORCE IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, African Swine Fever (ASF) is a highly contagious viral infection fatal to hogs and has already been detected in several countries resulting in millions of losses due to mortalities and preventive depopulation of pigs;

WHEREAS, latest report from the Provincial Veterinarian's Office (ProVet) reveal the presence of ASF on the specimen collected from, Barangay Buli, Pinamalayan, Oriental Mindoro;

WHEREAS, Pinamalayan ASF Task Force and Technical Working Group was created by virtue of Executive Order No. 08-2022 dated June 9, 2022;

WHEREAS, expansion of the composition of ASF Task Force and Technical Working Group is essential for a more efficient and well-coordinated response and immediate implementation of control measures;

WHEREAS, there is an urgent need to activate the Municipal Incident Command System to save lives, reduce health impacts, ensure public safety and meet the basic subsistence needs of the people affected by African Swine Fever (ASF).

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR, Local Chief Executive of Municipality of Pinamalayan, Oriental Mindoro by virtue of the powers vested in me by law, do hereby order the following:

Section 1. ACTIVATION OF MUNICIPAL INCIDENT COMMAND SYSTEM AND INCIDENT MANAGEMENT TEAM. The Municipal Incident Command System and Incident Management Team, composed of the following personnel, is hereby activated as an on-scene emergency response for the current widespread of African Swine Fever:

The Executive Conference Room located at Municipal Compound, Madrid Blvd., Zone III, Pinamalayan, Oriental Mindoro shall serve as the Incident Command Post.

All team leaders of Technical Support Teams are directed to report to the Incident Command Post whenever necessary.





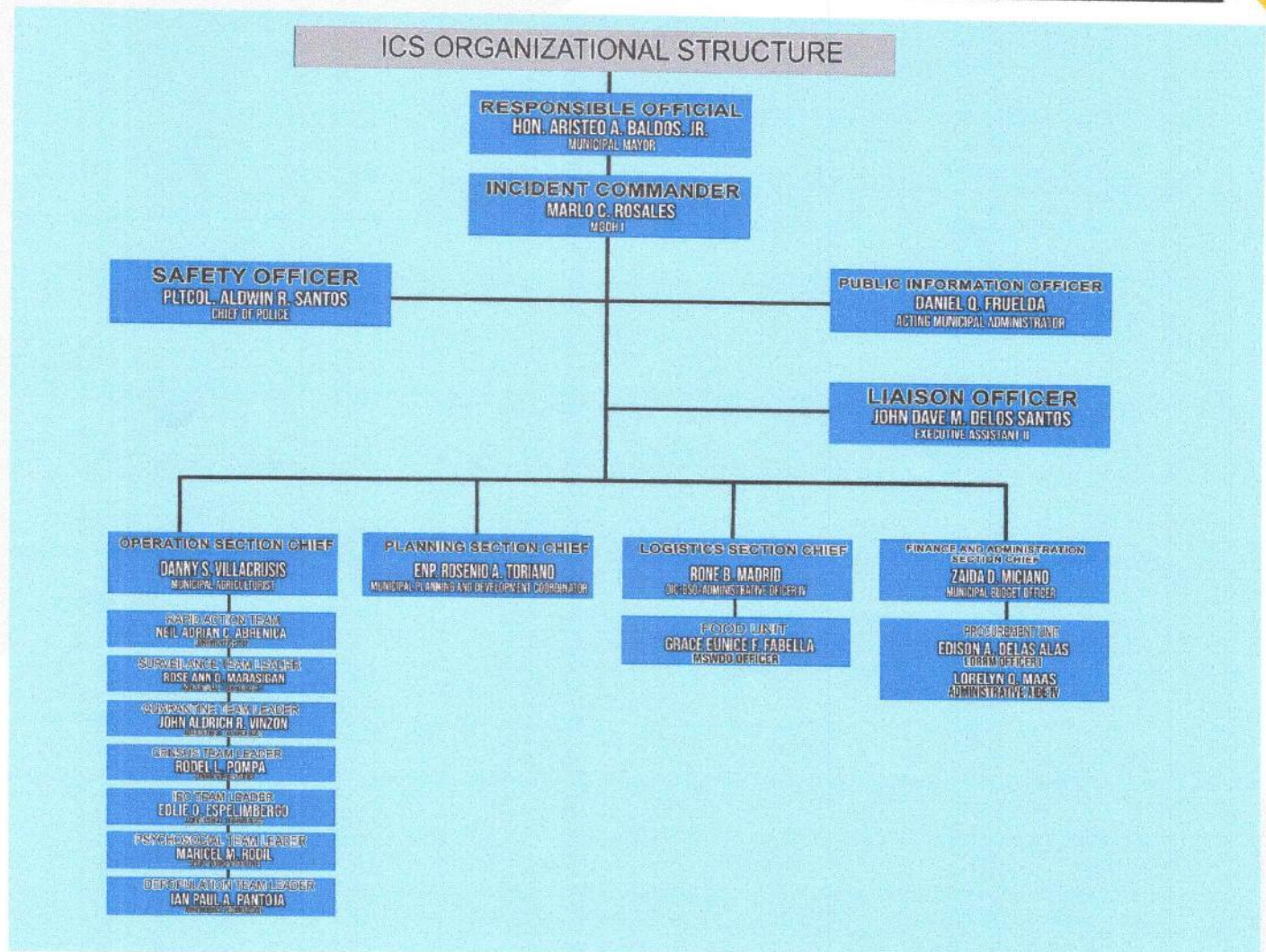

hogs laid down in Administrative Order No. 22 series of 2020 issued by the Department of Agriculture are hereby adapted *in toto* except the provision concerning the Quarantine Area.

Section 4. MANDATORY REPORTING BY THE BARANGAY OFFICIALS. It shall be the duty of all barangay officials to immediately report to the Municipal Agriculture Office, Bureau of Animal Industry, Provincial Veterinary and Office of the Municipal Mayor any incident of illegal transporting, culling and selling of hogs within their respective jurisdiction.

Section 5. BUDGETARY SUPPORT AND FUNDING. Funds needed for the operation of Task shall be made available from the General Fund and Municipal Disaster Risk Reduction and Management Fund (MDRRMF).

Section 6. EFFECTIVITY. This order shall take effect immediately.
