1. The Municipal Government of Pinamalayan, Oriental Mindoro, through the authorized appropriations under the **20% Development Fund** intend to apply the sum of **One Million Four Hundred Sixty Four Thousand Ninety Nine Pesos and Eighty Eight Centavos (1,464,099.88)** being the Approved Budget for the Contract (ABC) for the Project “**Installation of Solar Streetlights Sitio Remerco Brgy. Zone II.**”

Attachment Annex A for Technical Specification shall form part of ITB 2023-53

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. Bidders should have completed within the last three (3) years from the date of submission and receipt of bids at least one- (1) contract similar to the Project and whose value must be at least fifty percent (50%) of the Approved Budget for the Contract (ABC). The description of an eligible bidder is contained in the Bidding Documents, particularly in Section 5, Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the “Government Procurement Reform Act”.

4. Bid Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee amounting to Php **5,000.00** for the Bidding Documents.

The Invitation to Bid and Bidding Documents may be downloaded from the website of the Philippine Government Electronic System (PhilGEPS) and municipal government website (www.pinamalayan.gov.ph)

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel, who are familiar with the bid requirements and will prepare the documents for the bidder

The Municipal Government of Pinamalayan reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders. The Municipal Government of Pinamalayan likewise assumes no obligation whatsoever to compensate or indemnify any bidder or winning bidders, as the case may be, for any expenses or loss that said party(ies) may incur in its participation in the pre-bidding and bidding process nor does it guarantee that an award will be made.
