EXECUTIVE ORDER NO. 05-2024

AN ORDER RECONSTITUTING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) OF PINAMALAYAN ORIENTAL MINDORO

WHEREAS, Republic Act No. 7160, or the Local Government Code of 1991 provides for the constitution and organization of the Municipal Development Council in line with the national policy of encouraging local government units to evolve local development plans pursuant to existing laws, executive orders and other related issuances;

WHEREAS, R.A. 7160 mandates the organization and strengthening of local government councils, prescribing therein the compositions, organizations and functions of local development councils, as well as other related measures for the implementation of said Republic Act;

WHEREAS, Section 106 of the Local Government Code provides that each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its Sanggunian;

WHEREAS, the Municipal Development Council shall assist the local Legislative Body in setting the direction of economic and social development and coordinating development efforts within the municipality;

WHEREAS, Executive Order No. 01-2023, dated January 4, 2023 provides for the new composition of Municipal Development Council of Pinamalayan, Oriental Mindoro;

WHEREAS, there is a need to reconstitute the membership of the Municipal Development Council of Pinamalayan, Oriental Mindoro to strengthen the efforts of both the local government officials and non-governmental organizations to expedite the economic and social growth and development of the Municipality of Pinamalayan:

WHEREAS, the result of 2023 Local Elections brought changes in the new set of barangay officials, thus the need for reconstitution.

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Local Chief Executive of the Municipal Government of Pinamalayan, Oriental Mindoro, by virtue of the power vested in me by law do order and direct the reconstitution of the Municipal Development Council (MDC) as follows;

SECTION 1. COMPOSITION. The Municipal Development Council (MDC) in conformity with Section 107 (b) of the code, shall be composed of the following;

SECTION 2. FUNCTIONS. The Municipal Development Council shall exercise the following functions:

- Formulate long-term, short-term, and socio-economic development plans and policies;
- 2. Formulate medium-term and annual public investment programs;
- 3. Appraise and prioritize socio-economic development programs and projects;
- Formulate local investment incentives to promote the inflow and directions of private investment capital;
- Coordinate, monitor and evaluate the implementation of development programs and projects; and
- Each MDC member shall, as far as practicable, participate in at least one functional/sectoral committee;
- 7. Perform such other functions as may be provided by law or competent authority.

SECTION 3. CREATION OF EXECUTIVE COMMITTEE. The local development councils, by council resolution, shall create an Executive Committee. It shall be chaired by the Municipal Mayor and shall be composed of the following members:

One (1) representative of the Private/Non-Government Organizations Sector to be chosen by the private and NGOs Sector Members of the Council; and

SECTION 4. POWERS, FUNCTIONS AND RESPONSIBILITIES OF THE EXECUTIVE COMMITTEE. The Executive Committee shall have the following powers, functions and responsibilities:

- 1. Ensure that the decisions of the Council are faithfully and effectively carried out:
- 2. Act on matters that need the immediate attention and/or action of the Council;
- Formulate policies in accordance with the general principles laid down by the Council;

SECTION 6. FUNCTIONS OF FUNCTIONAL/SECTORAL COMMITTEE. Consistent with national policies and standards, the Functional/Sectoral Committees shall:

- a. Provide the LDC with data and information essential to the formulation of plans, programs, and activities.
- Define functional/sectoral objectives, set targets and identify programs, projects and activities for the particular sector or function;
- c. Collate and analyze information and statistics and conduct related studies;
- d. Conduct public hearings on vital issues affecting the functions/sector
- e. Coordinate planning, programming, implementation of programs, projects, and activities within each sectors;
- f. Monitor and evaluate programs and projects; and
- g. Perform such other functions as may be assigned by the LDC.

SECTION 7. SECRETARIAT. The Municipal Planning and Development Office shall act as Secretariat and shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharged of its functions. It shall be headed by the Municipal Planning and Development Coordinator (MPDC).

SECTION 8. MEETINGS. The MDC shall meet at least once every six (6) months or as often as may be necessary.

SECTION 9. REPEALING CLAUSE. All executive issuances which are inconsistent with or contrary to the provision of this Executive Order are hereby repealed.

SECTION 10. EFFECTIVITY. This Executive Order shall take effect immediately.
