EXECUTIVE ORDER NO. 13-2024

AN ORDER RECONSTITUTING THE SPORTS WORKING COMMITTEE OF THE MUNICIPAL GOVERNMENT OF PINAMALAYAN.

WHEREAS, Sec. 23 of the Off the Omnibus Rules Implementing Book V of Executive Order No. 292, states that it is the agency's responsibility to enable employees and officials to contribute meaningfully to organizational performance or productivity.

WHEREAS, the same rule states that every department or agency shall establish a continuing program for career and personnel development of human resources' skills, talents and value for better public service;

WHEREAS, in recognition of the human resource as the best asset of the organization, investing on programs and activities that promotes employees' well-being is considered as high priority for the better and efficient performance of its personnel;

WHEREAS, aware of the fact that there are several factors, both internal and external, that causes stress to the employees which affects their work performance, providing a day off from work and be engaged in leisurely yet challenging and physically-exhausting activities would not only relieve them from work-related stress but may also serve as an avenue to unleash their athletic prowess and help them become a leader, team player and team builder;

WHEREAS, the Municipal Government of Pinamalayan thru its Human Resource Management Office opted to bring into one engaging activity the Sports Olympics as an enabling mechanism to foster camaraderie and build stronger ties among all personnel;

WHEREAS, creating Sports Working Committee (SWC) in the Municipal Government Is essential in the implementation of the activity;

WHEREAS, Executive Order No. 15-2022 dated August 02, 2022 provides composition of Sports Working Committee of the Municipal Government of Pinamalayan.

WHEREAS, due to end of term of some members and appointment of additional sports coordinator, there is a need to reconstitute the council to update its membership and replace members who no longer represent the agency or organization.

NOW THEREFORE, I, **ARISTEO A. BALDOS**, **JR.**, Local Chief Executive of the Municipality of Pinamalayan, by virtue of the powers vested in me by law, do hereby order the reconstitution of Sports Working Committee of Municipal Government of Pinamalayan as follows:

SECTION 2. DUTIES AND RESPONSIBILITIES. To ensure the success of the Sports Olympics, the Sports Working Committee shall perform the following tasks and responsibilities:

- Formulate internal rules for the games;
- 2. Plan and implement the operation of the sports event;
- Oversee all aspects of the sports event;
- 4. Prepare and circulate the tournament schedule and results;
- 5. Make decisions that are on the best interest of employees; and
- 6. Do other tasks as may be required by the LCE for the implementation of the activity.

SECTION 3. EFFECTIVITY. This executive order shall take effect immediately upon its approval and shall remain enforced unless otherwise revoked.
