**EXECUTIVE ORDER NO. 18-2024**

**AN ORDER DECLARING TEMPORARY CLOSURE OF PORTION OF MADRID BOULEVARD FOR THE HOLDING OF SANGGUNIANG KABATAAN (SK) NIGHT**

**WHEREAS**, paragraph c of Section 21 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", provides that any national or local road, alley, park, or square may be temporarily closed during fiesta celebrations, agricultural or industrial fairs, the duration of which shall be specified by the local chief executive concerned in a written order;

**WHEREAS**, paragraph d of the aforesaid law states that any municipality, through a duly enacted ordinance may temporarily close and regulate the use of any local street, road, thoroughfare, or any other public place where shopping malls, Sunday, flea or night markets, or shopping areas may be established and where goods, merchandise, foodstuffs, commodities, or articles of commerce may be sold and dispensed to the general public;

**WHEREAS**, Section 56 of Municipal Ordinance No. 13-2020 or the Pinamalayan Traffic Management and Enforcement Code of Pinamalayan, Oriental Mindoro authorizes the Local Chief Executive to temporarily close any municipal roads/streets, thoroughfares or any public place for the purposes of establishing shopping stalls, Sunday flea or night markets or tiangge, Christmas bazar and baraklan and during the celebration of local and national holidays and conduct of cultural, civic and religious activities;

**WHEREAS**, the Municipal Government of Pinamalayan will be holding SK Night to be participated by Sangguniang Kabataan from various barangays of this municipality;

**WHEREAS**, in order to ensure the successful staging of the said event, the temporary closure of road in Pinamalayan, Oriental Mindoro is required.

**NOW, THEREFORE, I, ARISTEO A. BALDOS, JR.**, Local Chief Executive of the Municipality of Pinamalayan, by virtue of the powers vested in me by law do hereby order the temporary closure of portion of Madrid Boulevard for the holding of Sangguniang Kabataan (SK) Night.

**SECTION 1. SCOPE.** The portion of Madrid Boulevard, left side facing Strong Republic Nautical Highway, from corner Juan Luna Street to corner Jaena Street shall be closed during the conduct of the aforementioned activity.

**Section 2. DURATION.** To ensure the successful staging of the said event and to make necessary preparations such as sound system and stage and venue set-up, the temporary closure of portion of Madrid Boulevard shall take effect on April 21-22, 2024.

**SECTION 3. TERMS AND CONDITIONS.** The following terms and conditions shall be implemented:

- a. That a substitute route with corresponding routing plan shall be provided;
- b. That the alternate route shall be properly maintained for public safety until such duration that the subject road will be opened back to the public;
- c. That the residents of the area covered by the closure of road shall be given access;
- d. That all relevant laws and department orders appertaining temporary closure of roads and its guidelines shall be strictly followed.

**SECTION 4. SUPERVISION.** The Tourism and History Development Division (THDD) and Local Economic Development and Investment Promotion Office (LEDIPO) / Local Youth Development Office (LYDO) shall take charge of the public announcement informing the public that the aforementioned road is subject for temporary closure and stating the specific day and time.

The Traffic Management Office (TMO) and Pinamalayan Municipal Police Station shall render assistance to THDD and LEDIPO/LYDO for traffic planning, controlling and other traffic management related concerns.

**SECTION 5. EFFECTIVITY.** This Executive Order shall take effect immediately.

- e) All Officers of the association applying for Terminal Regulation Permit or other approval thereof shall have responsibility and obligation to discipline their members with respect to the use of the said terminals or its facilities.
- f) The Terminal Regulation Permit shall be valid for one year and shall be subject to renewal every year thereafter, approval of which shall be upon discretion of the issuing officer based on the association's performance.
- g) And such other regulatory acts deemed necessary in the implementation of this ordinance.

### SECTION 53. PENALTY -

- a) Failure to comply with the requirements stipulated herein shall cause denial of the application for Terminal Regulation Permit.
- b) Violation of any or all the provisions of this Article shall cause the suspension or cancellation of terminal permit or disapproval of renewal of application depending upon the discretion of the issuing officer.

### SECTION 54. IMPLEMENTATION

- a) The PTrAMED shall be tasked to monitor and submit written report to the Office of the Municipal Mayor relative to the implementation of this article.
- b) The concerned Barangay Officials where the terminal is located shall likewise be responsible for the implementation of this ordinance in coordination with the Office of the Municipal Mayor and shall also require submission of written report to the above mentioned office.

### SECTION 55. ISSUING OFFICE

The PTrAMED shall be the Issuing Office authorized to formulate and issue appropriate rules and regulations necessary for the efficient and effective implementation of any and all of its provisions.

### ARTICLE X CLOSURE OF MUNICIPAL ROADS

**SECTION 56. TEMPORARY CLOSURE** - The Municipal Mayor may temporarily close any municipal roads/streets, thoroughfare or any public place for purposes of establishing shopping stalls, Sunday Bazaars or night markets or tiangge, Christmas bazaar and baraklan where goods, merchandise, commodities or articles of commerce maybe sold and dispensed to the general public, and during:

- a) Wakes
- b) Parades
- c) Celebration of local and national holidays
- d) Cultural, Civic and Religious activities
- e) When public safety is at stake or at risk




