The Municipal Government of Pinamalayan, Oriental Mindoro, through the authorized appropriations under the **Supplemental Budget No. 6- 20% Development Fund** intend to apply the sum of **Three Million Sixty Eight Thousand Nine Hundred Twenty Eight Pesos and Eighty Eight Centavos (3,068,928.88)** being the Approved Budget for the Contract (ABC) for the Project “ **Road Rehabilitation Corner of Bonifacio St. To IHMA Along Madrid Blvd.**

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. submission and receipt of bids at least one (1) contract similar to the Project and whose value must be at least fifty percent (50%) of the Approved Budget for the Contract (ABC). The description of an eligible bidder is contained in the Bidding Documents, particularly in Section 5, Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the “Government Procurement Reform Act”.

4. Bid Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee amounting to Php **5,000.00** for the Bidding Documents.
