EXECUTIVE ORDER NO. 04-2025

AN ORDER FOR THE CREATION OF SAFE SPACE MONITORING TEAM (SSMT) FOR THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Section 2(c) of Republic Act No. 7160 or the "Local Government Code of 1991", declares it a policy of the State to require all national agencies and offices to conduct periodic consultations with appropriate local government units,

WHEREAS, Republic Act No. 11313 otherwise known as the "Safe Spaces Act (SSA)" expands the law on sexual harassment in the country to cover all of its forms including verbal, non-verbal, and physical. Further, it seeks to secure all persons, regardless of sex, sexual orientation, and gender identity and expression, from all kinds of gender-based violence and discrimination such as sexual harassment, not only in private spaces but also in public spaces.

WHEREAS, section 8 of SSA and Section 9 of its Implementing Rules and Regulations (IRR), mandate all local government units (LGUs) to prevent and respond to gender-based sexual harassment (GBSH) in the streets and public spaces.

WHEREAS, section 9 of SSA and Section 10 of its Implementing Rules and Regulations (IRR), mandate the Department of Interior and Local Government (DILG) to ensure the full implementation of Safe Space Act by assisting the LGUs in localizing the applicability of the law and monitoring their compliance.

WHEREAS, there is a need to create Safe Space Monitoring Team (SSMT) who will ensure the implementation of SSA as well as the additional functions of the monitoring team.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR., Local Chief Executive of Municipality of Pinamalayan, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby create The Municipal Safe Space Monitoring Team for the Municipality of Pinamalayan, Oriental Mindoro.

Section 1. COMPOSITION. The Municipal Safe Space Monitoring Team (MSSMT). Shall be composed of the following:

Section 2. DUTIES AND RESPONSIBILITIES. The Municipal Safe Space Monitoring Team shall:

1. Conduct site visits and assess the compliance of the Barangay Government, using **SSA Monitoring Form No. 1** based on the documents presented by the Barangay VAWC Desk Officer.
2. Discuss with the concerned punong barangays the outcome of the assessment and provide recommended actions to address the issues concerning compliance of the barangays to the localization of SSA; and
3. Consolidate and submit a report to the DILG Regional Office in the case of HUC and ICC or to the DILG Provincial Office in the case of Component City and Municipality, using **SSA Monitoring Form No. 2**; and
4. Ensure that the above-mentioned reports are encoded in the Shared Google Drive.

Section 3. SECRETARIAT. The Municipal Social Welfare and Development Office (MSWDO) shall serve as the focal office or secretariat of the Safe Space Monitoring Team.

Section 4. REPEALING CLAUSE. All orders, rules and regulations or parts thereof which are inconsistent with the provisions of this Executive Order are deemed repealed, amended or modified accordingly.

Section 5. SEPARABILITY CLAUSE. For any reason, any provision/s of this Order are declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue to be in force and effect.

Section 6. EFFECTIVITY. This Executive Order shall take effect immediately.
