**ITB-2025-14**

1. The Municipal Government of Pinamalayan, Oriental Mindoro, through the authorized appropriations under the **Supplemental Budget No. 1 2025** intend to apply the sum of **Two Million Nine Hundred Sixty Two Thousand Six Hundred Fifty Nine Pesos and Ninety Two Centavos (2,962,659.92)** being the Approved Budget for the Contract (ABC) for the Project **“Upgrading of Box Culvert (Single Barrel) in Mabini St. (Beside Eagle R Gas Station).**

Attachment Annex A for Technical Specification shall form part of ITB 2025-14

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. submission and receipt of bids at least one (1) contract similar to the Project and whose value must be at least fifty percent (50%) of the Approved Budget for the Contract (ABC). The description of an eligible bidder is contained in the Bidding Documents, particularly in Section 5, Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the “Government Procurement Reform Act”.

4. Bid Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee amounting to Php **5,000.00** for the Bidding Documents.

The Invitation to Bid and Bidding Documents may be downloaded from the website of the Philippine Government Electronic System (PhilGEPS) and municipal government website ([www.pinamalayan.gov.ph](http://www.pinamalayan.gov.ph))

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel, who are familiar with the bid requirements and will prepare the documents for the bidder
