You are required to post performance security within three (3) days from receipt of Notice of Award in the amount stipulated hereunder:



RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO BOTIKA NG BAYAN SA PINAMALAYAN AND RS MEDSTAR PHARMACY FOR THE PROCUREMENT OF DRUGS AND MEDICINES, ANTI-TB DRUGS AND RABIES VACCINE FOR MHO.

WHEREAS, the Municipal Government of Pinamalayan, sourced from **20% Development Fund** has allotted the amount **Three Million One Hundred Twenty Three Thousand One Hundred Sixty Five Pesos Only (3,123,165.00)** as the approved budget for the contract for **Procurement of Drugs and Medicines, Anti-TB Drugs and Rabies Vaccine for MHO.**

WHEREAS, the BAC Secretariat advertised the Invitation to Bid, and posted the same in the PhilGeps website, agency website and Municipal Hall bulletin Board, DILG/ABC Announcement Wall both located in the Municipal Compound and Bulletin Board Pinamalayan Public Market February 6, 2025 – March 12, 2025.

WHEREAS, the BAC conducted Pre-Procurement Conference on January 30, 2025 and Pre-bid Conference on February 19, 2025.

WHEREAS, the Bid Opening was held on March 12, 2025 and was participated by the Bidder:

WHEREAS, the BAC TWG subjected the BIDDERS to the required post evaluation of legal, technical and financial documents on March 14, 2025 in accordance with Revised IRR of RA 9184;

WHEREAS, the BAC after detailed evaluation resolved to adopt the observations /findings indicated in the TWG report as attached herein to form part of this resolution;

WHEREAS, this Committee resolved as it hereby resolves to:

1. DECLARE **BOTIKA NG BAYAN SA PINAMALAYAN AND RS MEDSTAR PHARMACY** as the Lowest Calculated Bidder in the **PROCUREMENT OF DRUGS AND MEDICINES, ANTI-TB DRUGS AND RABIES VACCINE FOR MHO.**

2. Recommend to the HOPE for the APPROVAL of the AWARD OF CONTRACT to **BOTIKA NG BAYAN SA PINAMALAYAN** for a contract price **Two Million One Hundred Seventeen Thousand Two Hundred Forty Five Pesos Only (Php 2,117,245 for Lot 1 & 3)** and **RS MEDSTAR PHARMACY** for a contract price **Nine Hundred Ninety Nine Thousand Six Hundred Eighty Three Pesos Only (Php 999,683.00 for Lot 2)** for the project of **PROCUREMENT OF DRUGS AND MEDICINES, ANTI-TB DRUGS AND RABIES VACCINE FOR MHO.**
