



**EXECUTIVE ORDER NO. 056-2025**

**AN ORDER RECONSTITUTING THE LOCAL YOUTH DEVELOPMENT COUNCIL OF PINAMALAYAN, ORIENTAL MINDORO**

**WHEREAS**, under 1987 Constitution, the State recognizes the vital role of the youth in nation building and shall protect their physical, moral, spiritual, intellectual, and social well-being;

**WHEREAS**, it is a declared policy of the municipality to promote and protect the physical, moral, spiritual, intellectual, cultural and social well-being of the youth and to inculcate in them values of patriotism and nationalism and to encourage their involvement in public and civic affairs of the municipality;

**WHEREAS**, due to changes in the membership and composition of the Council, there is a need to reconstitute the Local Youth Development Council of Pinamalayan to ensure updated, proper, and equitable representation of the youth sector.

**NOW THEREFORE, I, RODOLFO M. MAGSINO**, Local Chief Executive of Municipality of Pinamalayan, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Local Youth Development Council (LYDC) of the Municipality of Pinamalayan, Oriental Mindoro, as follows:

**Section 2. OBJECTIVES.** The following shall be the objectives of the Local Youth Development Council:

1. To develop the youth's full potential as a partner in nation building;
2. To encourage active participation of the youth in all programs and projects of the municipality;
3. To broaden and strengthen the services provided to the youth sector; and
4. To provide monitoring and coordinating mechanism for youth programs, projects, and activities.

**Section 3. FUNCTIONS.** The Local Youth Development Council shall perform the following functions:

1. To recommend to the Municipal Mayor policies and programs that are beneficial to the youth;
2. To coordinate and harmonize activities of all agencies and organizations in the city engaged in youth development;
3. To implement programs aimed at developing the full potential of the youth;

4. To assist the national government and provincial government and other national agencies in the promotion of programs, projects, and activities in the municipality;
5. To assist various government and non-government organizations in the identification and nomination of qualified participants to different programs, projects, and activities.
6. To conduct activities that will benefit the youth of the municipality;
7. To formulate and submit to the City Mayor the local youth agenda; and
8. To perform such other functions as may be required.

**Section 4. MEETING.** The council shall conduct a quarterly meeting or as the need arises. Assessment report shall be submitted on the status of every related activity.

**Section 5. REPEALING CLAUSE.** All executive orders, memoranda, and other issuances or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed, amended, or modified accordingly.

**Section 6. EFFECTIVITY.** This Executive Order shall take effect immediately.
