**EXECUTIVE ORDER NO. 058-2025**

**AN ORDER DIRECTING THE TEMPORARY CLOSURE OF PORTION OF MADRID BOULEVARD AND JAENA STREET INTERSECTION AND MADRID BOULEVARD AND LEUTERIO STREET INTERSECTION, BARANGAY ZONE III, PINAMALAYAN, ORIENTAL MINDORO**

**WHEREAS**, pursuant to Republic Act No. 7160, any municipality may temporarily close and regulate the use of any street, road thoroughfare, or public place where shopping malls, Sunday markets, flea or night markets, or shopping areas, may be established and where goods, merchandise, foodstuff, commodities, or articles of commerce may be sold and dispensed to the general public;

**WHEREAS**, Article X, Section 56 of Municipal Ordinance No. 13-2020 otherwise known as the Pinamalayan Traffic Management and Enforcement Code authorizes the Local Chief Executive to temporary close roads any municipal roads/streets, thoroughfares, or any public place for the purposes of establishing shopping stalls, Sunday flea or night markets or tiange, Christmas Bazar and Baraklan;

**WHEREAS**, the fabrication and installation of a double arc with decorative lightings along Madrid Blvd. and Jaena St. Intersection and Madrid Blvd. and Leuterio St. Intersection, Brgy. Zone III, Pinamalayan, Oriental Mindoro requires temporary road closure to ensure the safety of motorists, pedestrians, and workers during the conduct of the project;

**WHEREAS**, the temporary closure is deemed necessary to prevent accidents, ensure smooth implementation of the project, and maintain public order and safety.

**NOW, THEREFORE, I, RODOLFO M. MAGSINO**, Local Chief Executive of Municipality of Pinamalayan, by virtue of the powers vested in me by law, do hereby order the temporary closure of portion of Madrid Blvd. & Jaena St. Intersection and Madrid Blvd. & Leuterio St. Intersection for the fabrication and installation of double arc with decorative lightings in the Municipality of Pinamalayan, Oriental Mindoro, as follows:

**SECTION 1: TEMPORARY ROAD CLOSURE.** The portion of Madrid Blvd. & Jaena St. Intersection and Madrid Blvd. & Leuterio St. Intersection shall be closed for the fabrication and installation of double arc with decorative lightings.

**SECTION 2. DURATION.** The temporary closure of portion of the aforementioned street shall take effect on December 13-14, 2025.

**SECTION 3: TERMS AND CONDITIONS.** The following terms and conditions shall be implemented:

- a. That a substitute route with corresponding routing plan shall be provided;
- b. That the alternate route shall be properly maintained for public safety until such duration that the subject road will be opened back to the public;
- c. That the residents of the area covered by the closure of road shall be given access;
- d. That all relevant laws and department orders appertaining temporary closure of roads and its guidelines shall be strictly followed.

**SECTION 4. SUPERVISION.** The Tourism and History Development Division (THDD) and Municipal Engineering Office (MEO) shall take charge of the public announcement informing the public that the aforementioned road is subject for temporary closure and stating the specific day and time.

The Traffic Management Office (TMO) and Pinamalayan Municipal Police Station shall render assistance to THDD for traffic planning, controlling and other traffic management related concerns.

**SECTION 5. REPEALING CLAUSE.** All executive issuances which are inconsistent with or contrary to the provision of this Executive Order are hereby repealed.

**SECTION 6. EFFECTIVITY.** This Executive Order shall take effect immediately.
