EXECUTIVE ORDER NO. 060-2025

AN EXECUTIVE ORDER DESIGNATING MR. ACE BRIAN A. ALIMURONG AS ACTING MUNICIPAL ACCOUNTANT OF THE MUNICIPAL GOVERNMENT OF PINAMALAYAN

WHEREAS, the Municipal Government of Pinamalayan is mandated to ensure the continuous, efficient, and effective delivery of basic services, including sound fiscal management, proper accounting, and financial accountability, in accordance with existing laws, rules, and regulations;

WHEREAS, the position of Municipal Accountant became vacant by reason of the retirement of Ms. Judy D. Morente, former Municipal Accountant of the Municipality of Pinamalayan, effective January 01, 2026, thereby necessitating the designation of an officer to temporarily assume the duties and responsibilities of the said position;

WHEREAS, Mr. Ace Brian A. Alimurong has undergone the appropriate evaluation process and has been found to be qualified in accordance with the qualification standards set forth under the Omnibus Rules on Appointments and Other Human Resource Actions (ORAOHRA), and in compliance with all pertinent Civil Service Commission rules, regulations, and issuances;

WHEREAS, there is an urgent need to designate a qualified and competent officer to ensure the uninterrupted operations of the Municipal Accounting Office and the continued compliance of the Local Government Unit with accounting, budgeting, auditing, and financial reporting requirements.

NOW, THEREFORE, I, HON. RODOLFO M. MAGSINO, Municipal Mayor of the Municipality of Pinamalayan, Province of Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order:

Section 1. DESIGNATION. Mr. Ace Brian A. Alimurong is hereby designated as Acting Municipal Accountant of the Municipal Government of Pinamalayan, effective **January 01, 2026**, and shall continue to serve in such capacity until a new Municipal Accountant has been duly appointed or designated or until this designation is sooner revoked or modified.


Section 2. POWERS, DUTIES, AND FUNCTIONS. As Acting Municipal Accountant, Mr. Alimurong shall exercise and perform all the powers, duties, and functions inherent to the position, in conformity with existing laws, rules, and regulations, including but not limited to those issued by the Commission on Audit (COA), Civil Service Commission (CSC), Department of Budget and Management (DBM), and other relevant authorities.

Section 3. COMPENSATION AND BENEFITS. In recognition of your additional duties and responsibilities, you shall be entitled to receive such allowances and other benefits commensurate to your designation, subject to the availability of funds and in accordance with prevailing budgetary guidelines, policies, and auditing rules and regulations.

Section 4. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the remaining provisions not affected thereby shall remain in full force and effect.

Section 5. EFFECTIVITY. This Executive Order shall take effect on **January 01, 2026**, unless earlier revoked or modified.
