#### EXECUTIVE ORDER NO. 04-2026

#### AN ORDER RECONSTITUTING THE MUNICIPAL LUPONG TAGAPAMAYAPA INCENTIVES AWARDS (LTIA) COMMITTEE OF PINAMALAYAN, ORIENTAL MINDORO

**WHEREAS**, the state recognizes the time-honored Filipino tradition of settling, interpersonal disputes amicably through the Katarungang Pambarangay;

**WHEREAS**, establishing a municipal award system will not only facilitate healthy competition but expected to recognize a model Lupon among the Lurons of Pinamalayan;

**WHEREAS**, Executive Order 394 s. 1997 established the Lupon Tagapamayapa Incentives Awards and likewise encourage LGU's to establish the Local Lupon Tagapamayapa Awards Committee;

**WHEREAS**, there is a need to reconstitute the Municipal Lupon Tagapamayapa Incentives Awards (LTIA) Committee due to the change in administration and to update its membership to ensure alignment with current organizational structure and program requirements;

**NOW, THEREFORE, I, RODOLFO M. MAGSINO**, Local Chief Executive of Municipality of Pinamalayan, Oriental Mindoro by virtue of the powers vested in me by law, do hereby order the Reconstitution of the Municipal Lupon Tagapamayapa Incentives Awards (LTIA) Committee of the Municipal Government of Pinamalayan, as follows:

- c. Select and nominate to the Lupon Tagapamayapa Provincial Award Committee the best performing Lupon within the Municipality.

- d. Secure funding and counterpart prizes from partner agencies and the private sector; and
- e. Plan and implement appropriate award/incentive system and awarding ceremonies;

**Section 3: GENERAL CRITERIA IN EVALUATION.** Based on the DILG guidelines on the Lupong Tagapamayapa Awards, the following are the three general criteria in evaluating the best performing Lupon to wit:

- a. Efficiency in operations
  - Number of cases settled in relation to the number of cases filed
  - Observance of settlement procedures
- b. Effectiveness of securing KP objectives
- c. Creativity and resourcefulness of Lupong Tagapamayapa


**Section 4. FUNDING.** Funding requirements will be charged against the Katarungang Pambarangay/Lupong Tagapamayapa program. Other related funding requirements and specific award categories shall be determined by the Municipal Lupong Tagapamayapa Incentives Awards (LTIA) Committee.

All participating barangays will be given certificate/plaque of recognition. The Awards Committee will determine the amount of cash prizes.

**Section 5. REPEALING CLAUSE.** All executive orders, memoranda, and other issuances or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed, amended, or modified accordingly.

**Section 6. EFFECTIVITY.** This Executive Order shall take effect immediately.
