**EXECUTIVE ORDER NO. 05-2026**

**AN ORDER DIRECTING THE TEMPORARY CLOSURE OF JAENA AND BURGOS STREETS FOR THE HOLDING OF TRADE FAIR OR "BARAKLAN" IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO**

**WHEREAS**, paragraph c of Section 21 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", provides that any national or local road, alley, park, or square may be temporarily closed during fiesta celebrations, agricultural or industrial fairs, the duration of which shall be specified by the local chief executive concerned in a written order;

**WHEREAS**, paragraph d of the aforesaid law states that any municipality, through a duly enacted ordinance may temporarily close and regulate the use of any local street, road, thoroughfare, or any other public place where shopping malls, Sunday, flea or night markets, or shopping areas may be established and where goods, merchandise, foodstuffs, commodities, or articles of commerce may be sold and dispensed to the general public;

**WHEREAS**, Section 56 of Municipal Ordinance No. 13-2020 or the Pinamalayan Traffic Management and Enforcement Code of Pinamalayan, Oriental Mindoro authorizes the Local Chief Executive to temporarily close any municipal roads/streets, thoroughfares or any public place for the purposes of establishing shopping stalls, Sunday flea or night markets or tiangge, Christmas bazar and baraklan and during the celebration of local and national holidays and conduct of cultural, civic and religious activities;

**WHEREAS**, the Municipal Government of Pinamalayan recognizes and affirms the vital role of trade fairs as strategic platforms for stimulating local enterprise development, strengthening market linkages, attracting investments, and showcasing the municipality's products, services, culture, and tourism potential, thereby promoting inclusive, sustainable, and comprehensive economic growth and advancing the overall social and economic progress of the Municipality.

**NOW, THEREFORE, I, RODOLFO M. MAGSINO**, Local Chief Executive of Municipality of Pinamalayan, by virtue of the powers vested in me by law, do hereby order the temporary closure of Jaena and Burgos Streets for the holding of trade fair or Baraklan in the Municipality of Pinamalayan, Oriental Mindoro, as follows:

**SECTION 1. SCOPE.** In order to ensure public safety, maintain orderly conduct of activities, and provide adequate space for the implementation of the aforementioned event, the following streets shall be temporarily closed to vehicular traffic for the duration of the activity:

- Jaena Street, both sides from corner Madrid Blvd. to corner Mabini Street;
- Burgos Street, both sides from corner Mabini Street to corner Del Pilar Street

**Section 2. DURATION.** The temporary closure of portion of the aforementioned streets shall take effect on **March 07, 2025 to April 30, 2025.**

**SECTION 3. TERMS AND CONDITIONS.** The following terms and conditions shall be implemented:

- a. That a substitute route with corresponding routing plan shall be provided;

- b. That the alternate route shall be properly maintained for public safety until such duration that the subject road will be opened back to the public;
- c. That the residents of the area covered by the closure of road shall be given access;
- d. That all relevant laws and department orders appertaining temporary closure of roads and its guidelines shall be strictly followed.

For this purpose, the herein attached Vicinity Map shall form an integral part of this Order.

**SECTION 4. SUPERVISION.** The Local Economic Development and Investment Promotion Office (LEDIPO) shall take charge of the public announcement informing the public that the aforementioned road is subject for temporary closure and stating the specific day and time.

The Traffic Management Office (TMO) and Pinamalayan Municipal Police Station shall render assistance to LEDIPO for traffic planning, controlling and other traffic management related concerns.

**SECTION 5. EFFECTIVITY.** This Executive Order shall take effect on **March 07, 2026.**
