EXECUTIVE ORDER NO. 07-2026

AN ORDER RECONSTITUTING THE MUNICIPAL NUTRITION COMMITTEE (MNC) OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Republic Act No. 7160 has given the Local Government Units (LGUs) the power and authority to promote health and safety;

WHEREAS, the overall goal of Philippine Plan of Action for Nutrition (PPAN) 2023-2028 is the country's framework plan on nutrition is to contribute to the improvement of the quality of human resource in the country and reduce child and maternal mortality;

WHEREAS, DILG Memorandum Circular No. 2018-42 was issued on March 26, 2018 to provide guidelines on the roles and responsibilities of Local Government Units (LGUs) on the implementation of the PPAN 2023-2028;

WHEREAS, the nutrition program, being concerned with human resource development, is a vital and integral part of social reform and economic development;

WHEREAS, a functional local nutrition committee is critical to efficiently and effectively implement and manage the nutrition program;

WHEREAS, due to recent personnel movements, reassignments, and new appointments within the Municipal Government of Pinamalayan, there is a need to update the membership of the Municipal Nutrition Council to reflect the current officials and authorized representatives;

NOW, THEREFORE, I, RODOLFO M. MAGSINO, Local Chief Executive of Municipality of Pinamalayan, Oriental Mindoro, by virtue of the powers vested in me by the law, do hereby order the reconstitution of Municipal Nutrition Committee (MNC) of Pinamalayan, Oriental Mindoro, as follows:

Section 2. FUNCTIONS. The Municipal Nutrition Committee shall perform the following:


1. Formulate, coordinate, implement and monitor the nutrition program;
2. Generate and mobilize resources;
3. Integrate the existing nutrition related projects and activities;
4. Revitalize the Barangay Nutrition Committees;
5. Coordinate the release of public funds for nutrition purposes in accordance with the approved projects and programs.

Section 3. MEETINGS. The Municipal Nutrition Committee shall meet once every quarter presided by the local chief executive or designated representative.

Section 4. REPEALING CLAUSE. All executive orders, memoranda, and other issuances or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed, amended, or modified accordingly.

Section 5. EFFECTIVITY. This Executive Order shall take effect immediately.
