EXECUTIVE ORDER NO. 015-2026

AN ORDER DESIGNATING ENP ORLEX H. MARAYAN AS ACTING MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR (MPDC) OF THE MUNICIPAL GOVERNMENT OF PINAMALAYAN

WHEREAS, the Municipal Government of Pinamalayan is mandated to promote the general welfare of its constituents through the formulation and implementation of responsive, integrated, and sustainable development plans, programs, and projects;

WHEREAS, the Municipal Planning and Development Coordinator (MPDC) is a key local government official tasked with providing technical assistance to the Local Chief Executive and the Sangguniang Bayan in setting the direction of development planning, and in coordinating, monitoring, and evaluating the implementation of development initiatives in accordance with existing laws, rules, and regulations;

WHEREAS, the continuity, efficiency, and effectiveness of planning and development functions within the Municipality must be ensured at all times in order to sustain institutional operations and deliver quality public service;

WHEREAS, there exists a necessity to designate an Acting Municipal Planning and Development Coordinator pending the appointment of a permanent official to the said position, in order to avoid disruption in the performance of essential governmental functions;

WHEREAS, EnP Orlex H. Marayan has demonstrated competence, capability, integrity, and sufficient experience in public service, thereby making him qualified to temporarily assume and discharge the duties and responsibilities of the Municipal Planning and Development Coordinator.

NOW, THEREFORE, I, HON. RODOLFO M. MAGSINO, Municipal Mayor of the Municipality of Pinamalayan, Province of Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order:

Section 1. DESIGNATION. EnP Orlex H. Marayan is hereby formally designated as Acting Municipal Planning and Development Coordinator (MPDC) of the Municipal Government of Pinamalayan, effective 07 April 2026, until such time that a permanent appointee shall have been duly appointed and qualified for the position, or until this designation is earlier revoked.

Section 2. AUTHORITY AND FUNCTIONS. As Acting MPDC, Mr. Marayan shall exercise the powers, perform the duties, and discharge the responsibilities inherent to the position as provided under existing laws, including but not limited to planning formulation, program coordination, project monitoring and evaluation, and provision of technical assistance to the Local Chief Executive and other offices of the Municipality. He shall likewise perform such other duties as may be lawfully assigned by the Municipal Mayor.

Section 3. COMPENSATION AND ENTITLEMENTS. The designated Acting MPDC shall be entitled to such compensation, honoraria, allowances, and other benefits as may be authorized under existing budgeting, accounting, and auditing rules and regulations, subject to the availability of funds and applicable guidelines issued by oversight agencies.
