EXECUTIVE ORDER NO. 19-2026

AN ORDER RECONSTITUTING THE MUNICIPAL TASK FORCE KNOWN AS "BANTAY KARNE" IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, the Local Government Code of 1991 (Republic Act No. 7160) requires the provincial, municipal, and city governments to regulate the preparation and sale of meat for public consumption while the Code of Sanitation of the Philippines (Presidential Decree No. 856) provides for the sanitary requirements in the operation of markets;

WHEREAS, the Meat Inspection Code of the Philippines (Republic Act No. 9296), requires the National Meat Inspection Services to provide regulations to ensure the safety, quality, and wholesomeness of meat and meat products;

WHEREAS, Municipal Ordinance No. 01-2023, enacted by the Sangguniang Bayan on February 13, 2023, provides for the regulation of sale, transport, and handling of meat in meat markets in the Municipality of Pinamalayan;

WHEREAS, Section 16 of the aforementioned Ordinance mandates the creation of the Municipal Task Force known as "Bantay Karne";

WHEREAS, the creation of the Municipal Task Force "Bantay Karne" is necessary to oversee the implementation of Municipal Ordinance No. 01-2023 and other related activities as may be provided by rules and regulations and guidelines promulgated by higher authority or mandated by national laws;

WHEREAS, there is a need to reconstitute and operationalize the Municipal Task Force "Bantay Karne" in accordance with said ordinance, and to clearly define its composition, implementation support, and coordination mechanisms for effective enforcement;

NOW, THEREFORE, I, HON. RODOLFO M. MAGSINO, Local Chief Executive of the Municipality of Pinamalayan, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Municipal Traffic Task Force known as "Bantay Karne" in the Municipality of Pinamalayan, Oriental Mindoro, as follows:

SECTION 1. COMPOSITION. The Municipal Task Force "Bantay Karne" shall be composed of the following:

SECTION 2. DUTIES AND FUNCTIONS OF THE TASK FORCE. The Municipal Task Force "Bantay Karne" shall perform the following duties and functions:

1. Serve as the main implementer of Municipal Ordinance No. 01-2023;
2. Formulate local issuances, memoranda, and circulars for the effective monitoring and safeguarding of meat handling, sale, transport, and distribution;
3. Apprehend violators in accordance with Municipal Ordinance No. 01-2023;
4. Disseminate information, guidelines, and memoranda to all concerned stakeholders;
5. Regularly submit reports to the Local Chief Executive on the status of its activities;
6. Conduct regular monitoring and surveillance of day-to-day operations in meat markets and related establishments; and
7. Perform such other functions as may be necessary for the full and proper implementation of Municipal Ordinance No. 01-2023.

SECTION 3. IMPLEMENTING OFFICES AND AREAS OF RESPONSIBILITY. The following offices shall serve as the primary implementing offices of Municipal Ordinance No. 01-2023 and shall provide technical, regulatory, enforcement, and coordination support to the Bantay Karne Task Force:

a. The Market Operations Department and the Slaughterhouse Operations Division shall lead the implementation of this Ordinance. The Municipal Agriculture Office, Municipal Health Office, and the Philippine National Police – Pinamalayan MPS, shall provide the necessary assistance to the lead offices.

b. The Slaughterhouse Operations Division shall regularly coordinate with the National Meat Inspection Service (NMIS) to ensure effective implementation of this Ordinance; and

c. The Slaughterhouse Operations Division, in coordination with the concerned barangays, shall monitor the compliance of meat shops in their jurisdiction.

SECTION 4. CONDUCT OF MEETINGS. The Bantay Karne Task Force shall meet quarterly, or as often as necessary, to monitor and evaluate compliance to the Ordinance, discuss enforcement issues, and recommend appropriate actions.

SECTION 5. SECRETARIAT. The Slaughterhouse Operations Division shall serve as the Secretariat of the Bantay Karne Task Force, to be headed by **MS. ANTONETTE R. ABEL**, Administrative Aide IV, and shall provide the necessary technical and administrative support, including documentation of proceedings and activities, preparation of communications, maintenance of documents and records, consolidation of reports, and coordination of meetings and enforcement activities.

SECTION 6. REPEALING CLAUSE. All executive issuances which are inconsistent with the provisions of this Executive Order are hereby repealed, amended, or modified accordingly.

SECTION 7. EFFECTIVITY. This Executive Order shall take effect immediately.
